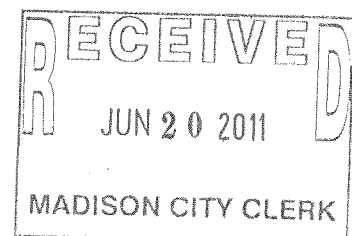

There is one dwelling unit on the property.

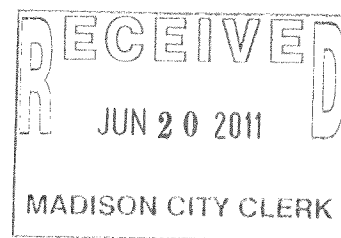

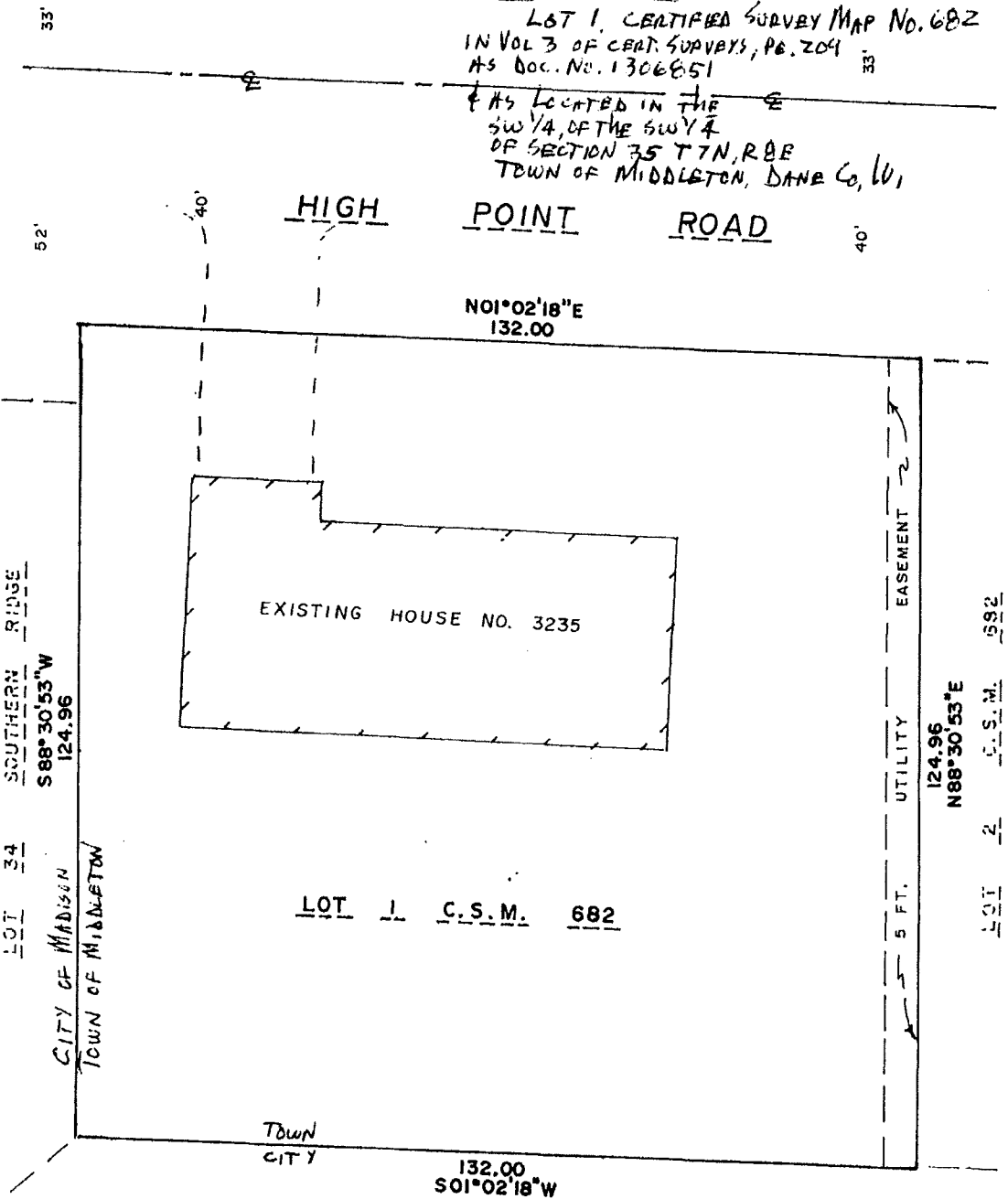
