

PERMITTING YOUR MOPED

• Residential Parking Permit Program (RP3)

The RP3 permit allows people who live at an **eligible address** to park in excess of the posted one or two hour parking limit on the street.



The permit year begins September 1 and ends August 31 of the following year.

Permit cost is \$28.00 for each permit year. Replacement permits are \$7.00.

• Annual Parking Permits for Assigned Garages

The permit year begins April 1 and ends March 31 of the following year.

The annual motorcycle parking permit fee is \$225 per year.

Permits are valid from 6 am to 10 pm, Monday through Friday, for the designated garage.

If you park outside of the permit hours, you will be responsible for payment of the hourly rate.

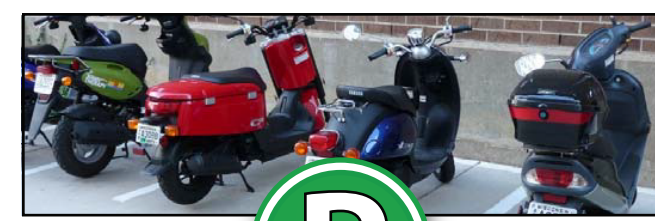

The Ordinance has changed

As of January 1, 2018, mopeds will no longer be permitted to park on sidewalks and terrace areas, or at bicycle racks, unless the area is specifically signed and/or marked as a moped parking area.



WHERE TO PARK

On-Street

Mopeds and motorcycles can park on-street in any legal space in accordance with signage and other parking regulations.

Up to 3 mopeds and motorcycles can park in a standard auto metered stall. The cost of parking at a standard on-street metered space is \$2:00 per hour.

The cost for parking in a designated moped and motorcycle metered space is \$1.00 per hour.

Residential parking permits may be purchased for mopeds/motorcycles in accordance with program eligibility requirements.

All time limits and restrictions must be observed.

48 hour time limit applies for street parking of all vehicles.

Off-Street

For safety reasons, mopeds should not go through gated entry lanes to access parking at off-street parking facilities.

Mopeds and motorcycles are allowed at metered spaces and designated moped/motorcycle spaces.

TERRACE LOCATIONS

Property owners may apply to establish terrace moped parking areas. At the time of publication, no terrace parking areas have been established. A future list of approved terrace locations will be available at:

Mopeds may park on the terrace in **designated, officially-signed** locations only.

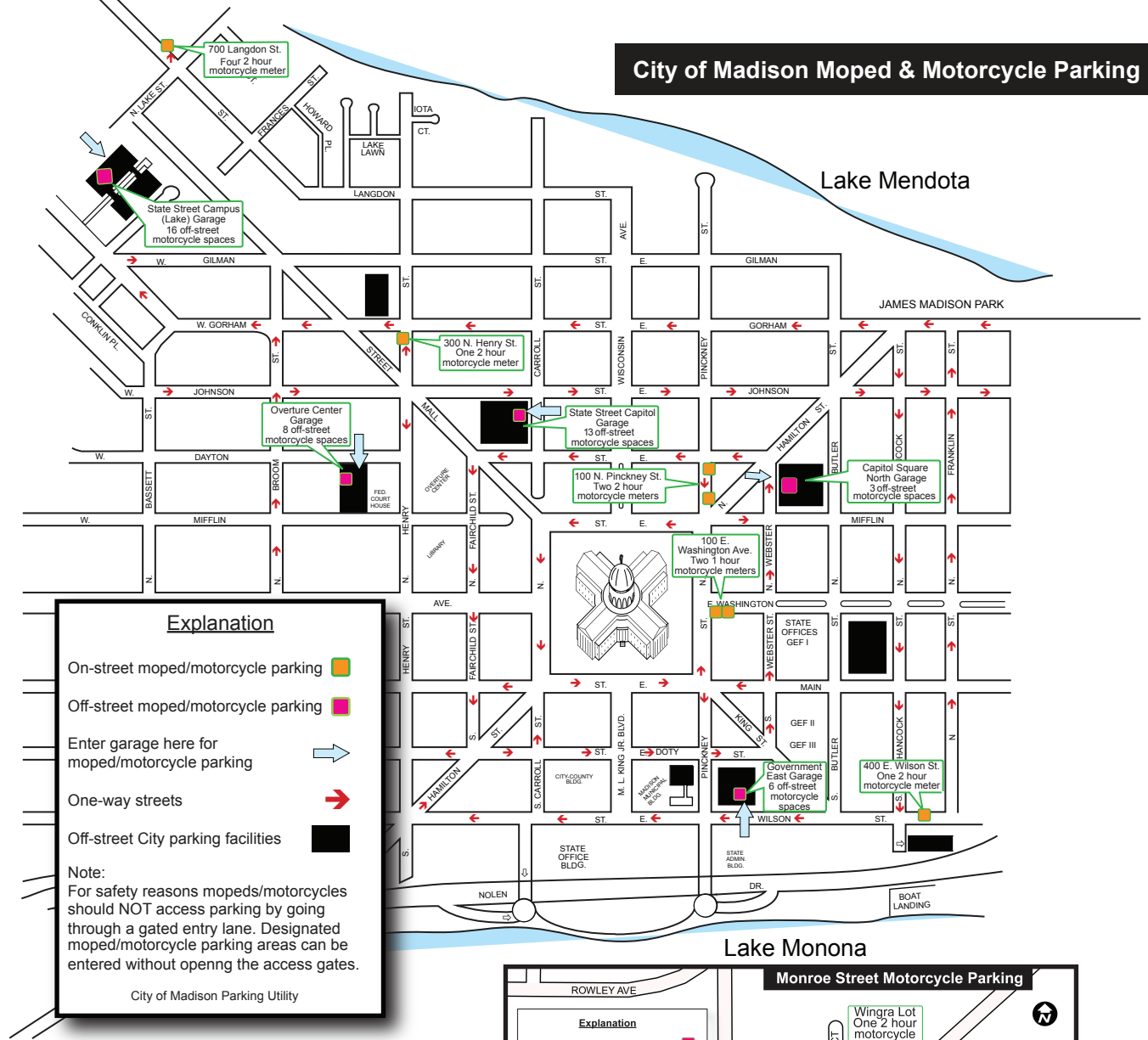
Mopeds must be parked within marked stall lines. 48 hours is the maximum time limit for terrace parking.

The street **terrace** is the space that lies between the sidewalk and the curb.



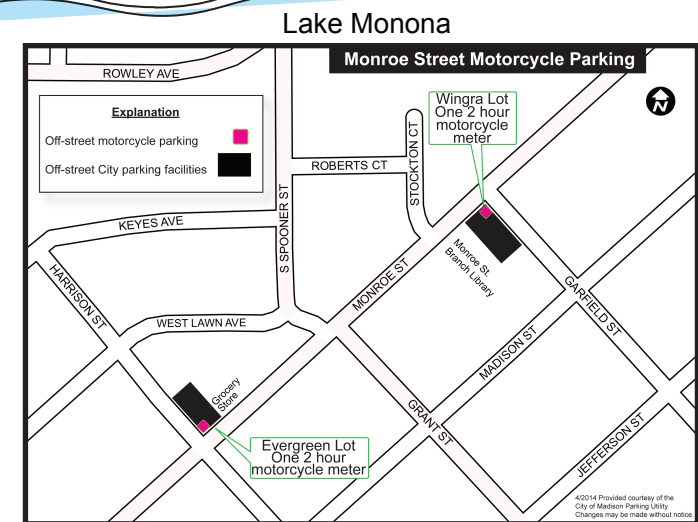
