Christy Bachmann, City Engineering Division, presented details of the request for construction work, with associated noise impacts between the hours of 7:00 p.m. and 7:00 a.m., for the work being done on the 10 blocks of East & West Mifflin Street, North Carroll Street and North Pinckney Street between W. Washington Ave. and E. Washington Ave. (Capitol Square, north half).

She said that 10 p.m. would be latest construction would go and this would happen five single days through out the project. Jim Wolfe, City project engineer, has received communication from the Downtown Business District, requesting Monday through Wednesday as preferred days for the work to be done and that will factor heavily into when water is shut off and late work is scheduled. Bachmann said Ald. Verveer, who represents the district impacted by the construction, supports the later work hours. (Ald. Verveer arrived late to the meeting, after this agenda item was dispensed. He thanked stakeholders for their work on the project and patience with construction impacts).

The Public Hearing was opened. Two members of public were present, both with connections to construction companies working on the Capitol Square project. They said they attended for information on water shut offs. Both have been in communication with Jim Wolfe (the project engineer) and will continue to communicate.
