Hello,

Although I cant attend the Wed. mtg., I'd like to give my family's voice to discussion regarding Monona Ct as One Way.

- Although some disagree, one of the most disconnecting aspects of our Lake Edge neighborhood is the extreme lack of safe, ACCESSIBLE pathways for those of all ages and abilities to get out and about. i.e. no sidewalks.
- It's colloquially known that Monona Ct.'s the only lazy street to teach kids to ride, casually walk the dog without blaze orange reflectors and lights, and roll the stroller without getting splashed or slushed by fast moving traffic on chemically salted streets, often in the dark.
- Since the neighborhood majority is opposed to sidewalks during road reconstructions, Monona ct being left as ONE WAY is at the very least a compromise worth considering. I also think it important to tell neighbors who have garages on Monona ct. to feel free to drive in from whichever side. We get it. We empathize with "the shortest route from work".
- To this point, personally, a particular neighbor who has led this appeal and petitioning for Monona ct 2-way in the past has been aggressive in his persuasion to the point that my wife signed it last year to make him leave our front door. She then wrote to our previous Alder to remove her signature and explained why. His considerations are singularly minded and discounts the needs of our community at large. In lieu of a petition by the few, I'd be interested to see a majority neighborhood association vote before giving credence to the petition.
- Additionally, making Monona ct a 2 way would not only make the alley busier, it would congest it dangerously with 2 rows of traffic AND kids and dogs and strollers when frankly, it has only room for 1 car. Families have to move off the road as it is now to make way for a car. I cant imagine cars coming from both ends of the block and trying to navigate the family.
- Lastly, I think it would be amazing to consider Monona Ct. for permeable pavement given the low & light traffic. Its in desperate need of repaving as well and might do well as a neighborhood Green Street thoroughfare. https://www.epa.gov/G3/learn-about-green-streets.

If you were to have any influence on further road construction in the neighborhood, I'd be more than happy to get involved behind a Permeable Pavement Sidewalk Option.
