Summary of the Martin v. Boise case and potential implications for the City of Madison - City of Madison Attorney's Office

Assistant City Attorney McReynolds provided information about the Martin v. Boise case.

Applicability to the City of Madison:

- Only binding in the 9th circuit.
- No City of Madison ordinance violation is a criminal violations.
- City of Madison ordinances are not as sweeping as those of Boise. In

Boise, they were broad, all sleeping at all times at all places were not permitted.

Assistant City Attorney Peguero reviewed the list of the City of Madison ordinances related to sleeping in public spaces and how many citations were issued in the last five years 2015-2019 for each ordinance.

Konkel discussed ordinances, and concept of “moving people along”. The accumulative effect is that there are very few legal places for people to be able to sleep without risking a ticket. Discussion regarding receiving tickets for non-sleeping issues, such as public urination, possession and consumption of alcohol, and trespassing. Having fines from citations is a significant barrier to obtaining housing.
