Please ask City Engineering and Traffic Engineering to move forward with a street design that takes into account the needs of people biking and walking on this important connection to downtown, both going west to east, and east to west. I strongly oppose an option that mixes people walking and cycling on the sidewalk, as that is neither safe nor convenient for anyone. I support doing a well-designed and evaluated pilot project that would close one of the on-street parking lanes to put in a protected one-way or two-way bike lane.

As a member of the city's ad hoc South Capitol TOD committee, I remember the discussions of this corridor in the public meetings, and specifically the objections of some neighborhood residents to sharing the sidewalks with bicyclists. As an active transportation planner, I predict that reconstructing the street without adequate accommodations for bicyclists IN THE STREET will result in timid cyclists riding on the sidewalk, which will cause resentment among many pedestrians, and yet some confidant cyclists will ride in the street (potentially in both directions, only one of which is lawful under current conditions or the proposed plan), which will cause resentment among car drivers. Asking people on foot and people on bikes to share an 8' sidewalk is a recipe for failure all around. Since roughly half of people in the downtown area get to work by some mode other than driving alone in a car (according to US Census journey to work data), and it's likely the active mode share for trips other than the commute is even higher, how about allocating more of the scarce space on the street to people who are not in cars?

In a Nutshell:

I write regarding the West Wilson Street redesign. I oppose moving bikers onto an 8' sidewalk shared with pedestrians. Mixing users that move at very different speeds always leads to problems. Bikers will be annoyed with pedestrians getting in their way and pedestrians will be annoyed at bikers who zip by too fast or too close. Marking pedestrian and bike lanes will do little to resolve the basic conflict with this design.

I support running a well designed pilot project that replaces one parking lane with a two way bike lane. Pilot projects can be implemented inexpensively and can produce high quality feedback on what works and what doesn't for all road users. We will never know how many bikers will use the street until we make space for them.

The backstory:

Cities are messy. Nobody gets everything they want. Compromises must be made. We have a rare opportunity to evolve Wilson Street to better serve more people.

In the past, we have designed primarily for the car at the clear expense of walkers and bikers. Times are changing and all the people moving back into center cities are not doing it because they love car traffic. They are doing it because they love vibrant streets filled with people. People they can see and chat with when they are walking and biking around town.

Every project should be forward thinking rather than accepting the status quo we inherited from past generations. City center life is clearly moving away from cars and toward more biking and walking. To build for cars at the expense of biking and walking is a waste of tax payer money and comes with the social cost of discouraging walking and biking and all the financial, health, and other social benefits they bring.

W. Wilson reconstruction

Dear members of the BoPW -

Before you make a decision on what W. Wilson should look like after reconstruction, I would like to suggest a little experiment:

Check out a BCycle outside the CCB. Ride west on W. Wilson in peak hour traffic. Don't forget that the right lane becomes a right-only at Hamilton, so you should probably change into the left lane before getting there.

Now ride the same bike back to the CCB. The fastest way would be to ride up S. Hamilton, but it's pretty steep. N. Henry is less steep, but still a challenge on any bike, much less a BCycle. You could take the sidewalk, but it's pretty narrow, and even the additional two feet Engineering is proposing is not going to be enough to make it comfortable for both pedestrians and the many bicyclists that need to travel eastbound. In addition, imagine that many of the more timid or less-experienced westbound bicyclists will also be using that same sidewalk.

If you chose the sidewalk, think how you could legally continue on east to access the two-way portion of E Wilson and the Isthmus Path. Notice all the people entering and leaving the surrounding buildings and that riding on the sidewalk is both unsafe and illegal.

If you don't feel safe on a bike, maybe walk the same route, but notice the options for those on bikes.

Now consider how much easier and safer it would be for both pedestrians and bicyclists if there was a protected and comfortable-for-all-ages-and-abilities lane where the parking exists on the south side of W. Wilson. We could have both eastbound and westbound bicyclists using that lane and staying out of the way of pedestrians and drivers.

We live on an Isthmus, with limited options into and out of downtown. We need to use our limited space in the most efficient way possible. Single-occupancy vehicles and curb-side parking are not efficient use of that limited space.

All the transportation plans the city has worked on, paid for, and adopted in the last five years say that we must move to more use of transit, walking, and bicycling in order to efficiently move people in our downtown and throughout the city. All plans have also pointed to E. and W. Wilson as a significant gap in the bicycling network and the resulting bicycling on the sidewalks as both an annoyance and danger to pedestrians. All plans state that creating infrastructure that feels and is safe for bicyclists of all ages and abilities is one of the key steps in encouraging more utilitarian bicycling.

You have a chance to fix the gap in the network that exists. That is the only way we will get more people on bikes. Filling this gap by separating people walking and people bicycling is also good for pedestrian comfort and safety.

We have done the easy things. The low-hanging fruit has been picked. We must now make the hard decisions: Continue to facilitate inefficient transportation, or make the changes that will create a more efficient system for all.

A two-way, protected bike lane in place of the parking on the south side is the 21st Century choice. Please make that happen. After your bike ride or walk, you will know it is the right choice.


