Lucia Nunez distributed materials and explained the City of Madison Disparity Study and the Dept. of Civil Rights Affirmative Action Divisions' involvement in the Study. \$400,000 is in the City Budget for a disparity study to determine the feasibility to including Disadvantaged Business Enterprise (DBE) firms in Public Works construction project goals. A disparity study is necessary to establish a basis to include DBE goal setting in projects not receiving federal financial assistance. She reviewed the timeline and the involved organizations and staffing. On future agendas, the Disparity Study will be part of her and Norman Davis' AAC reports.

07972 COMMON COUNCIL UPDATE BY ALD. CLAUSIUS--Presented for information only. No action required.

Alder Clausius reminded the Commission that the Council was on holiday hiatus for 30 days. The upcoming April 2nd election will affect the Council makeup since four council members are not running again and nine council members are running opposed. The homeless projects are priorities for the Council and Alder Clausius is very supportive of these projects. Occupy Madison is interested in buying a building and converting it to eight single units. Care Net, which helps young single new mothers, is proposing a 36 unit building right next to their present building on the far east side.
