Under the terms of the Town of Middleton, Wisconsin and Madison, Wisconsin cooperative plan under section 66.0307, Wisconsin statutes dated September 29, 2003 and the certain Intergovernmental Agreement between the Town of Middleton, Wisconsin and Madison Wisconsin dated March 28, 2002 (collectively, the "Governing Documents"), it was agreed that certain territories may be attached and added to Madison, Wisconsin with notice to the Town Clerk for the Town of Middleton, Wisconsin and by the adoption of an Attachment Ordinance by a majority of elected members of the Common Council of Madison, Wisconsin.

The petitioners request that the property be temporary zoned once it has been attached to Madison, Wisconsin.
