Commencing at the Center of said Section 31; thence S89°36'03"E along the south line of said Northeast quarter, 509.04 feet; thence N0°23'57"E, 1417.96 feet to the West right-of-way line of Pankratz Street, being N2°16'18"E, 4.44 feet from the Northeast corner of Lot 4, Certified Survey Map No.13328 also being the point of beginning; thence N87°43'42"W, 194.41 feet; thence S80°32'56"W, 95.70 feet; thence N87°43'42"W, 72.43 feet to a point of curve; thence Southwesterly 57.82 feet on a curve to the left with a radius of 40.00 feet and a chord bearing S50°51'42"W, 52.92 feet; thence N87°43'42"W; 12.33 feet; thence N0°21'33"E, 100.05 feet; thence S87°43'42"E, 12.01 feet; thence S0°21'34"W, 1.67 feet to a point of curve; thence Southeasterly on a curve to the left, 76.87 feet with a radius of 50.00 feet and a chord bearing S43°41'05"E, 69.52 feet; thence S87°43'42"E, 53.25 feet; thence N73°03'24"E, 89.46 feet; thence S87°43'42"E, 216.12 feet to the West right-of-way line of Pankratz Street; thence S2°16'18"W, along said West right-of-way line, 25.00 feet to the point of beginning.

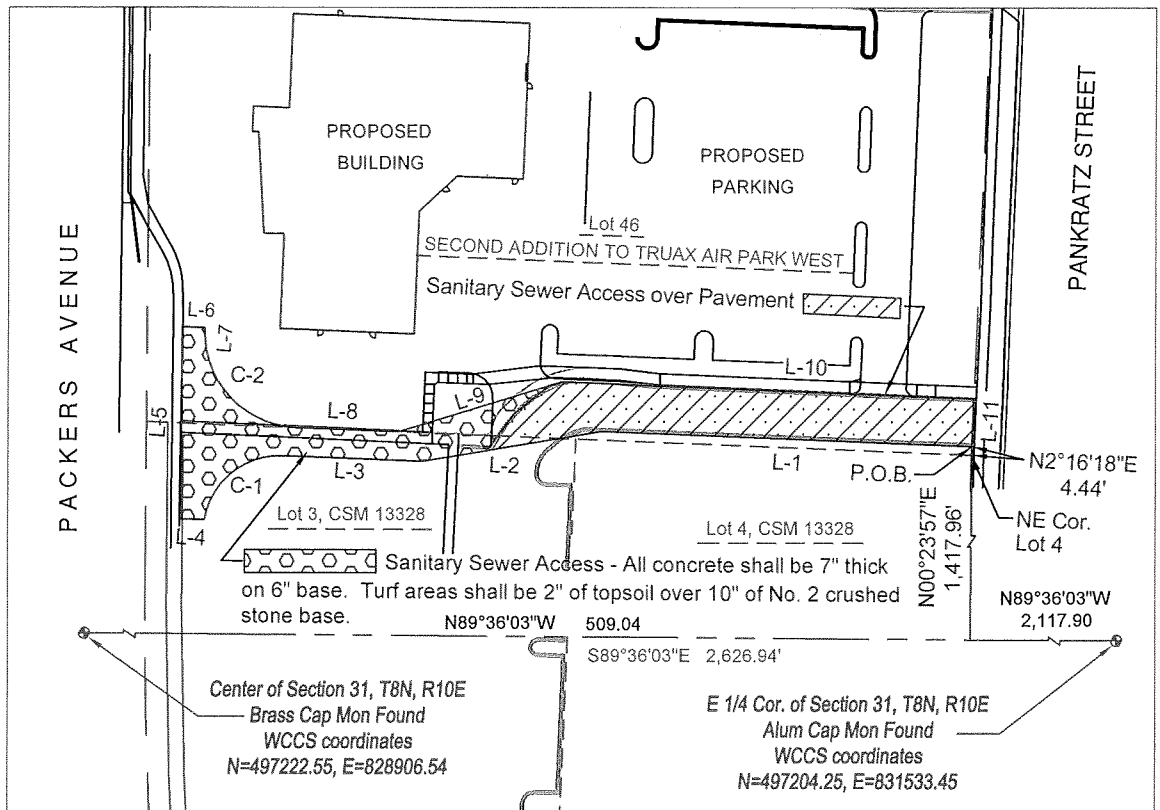

Sanitary Sewer Access Easement "A"

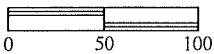

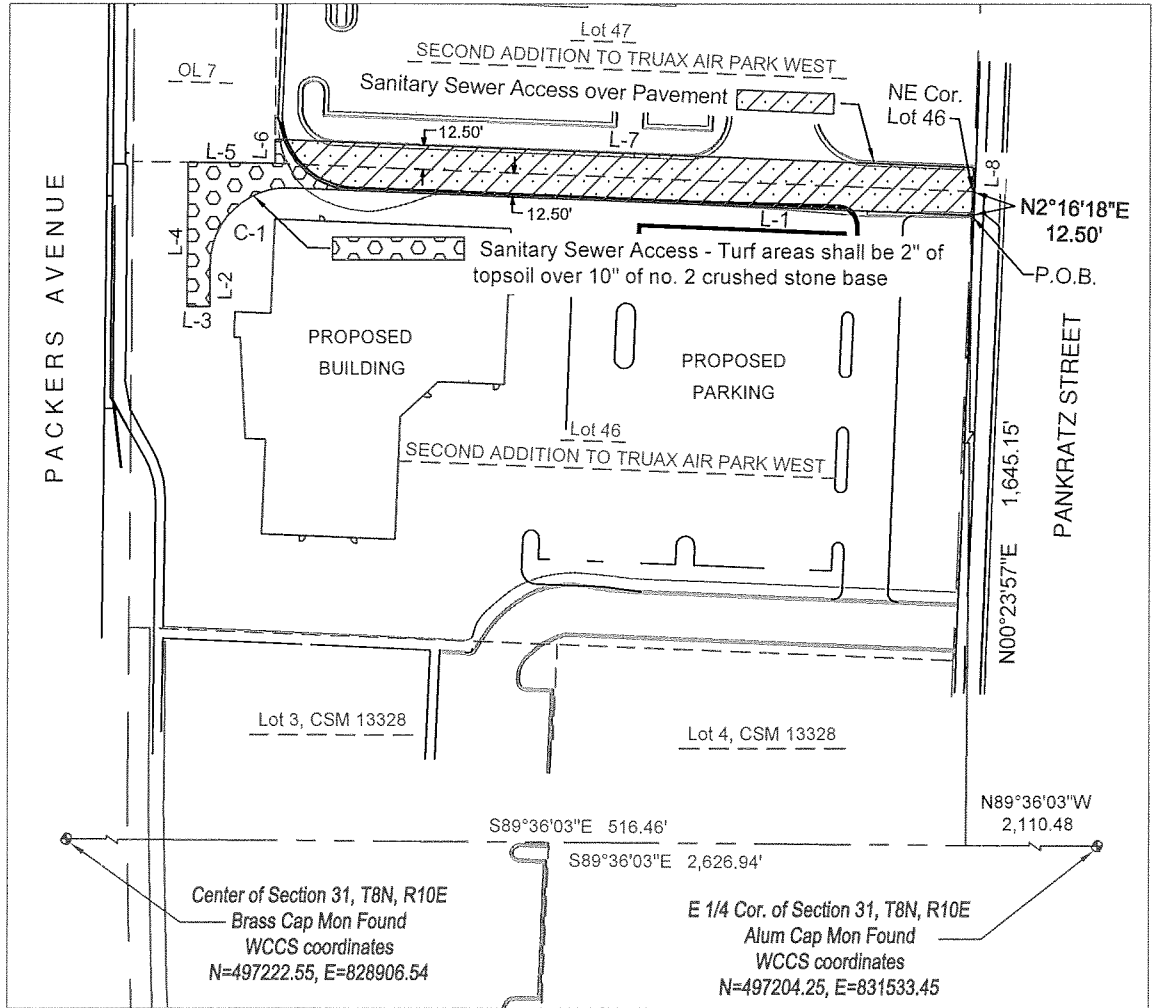

Sanitary Sewer Access Easement "B"

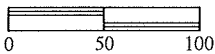
