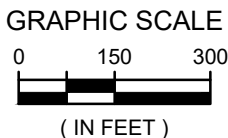
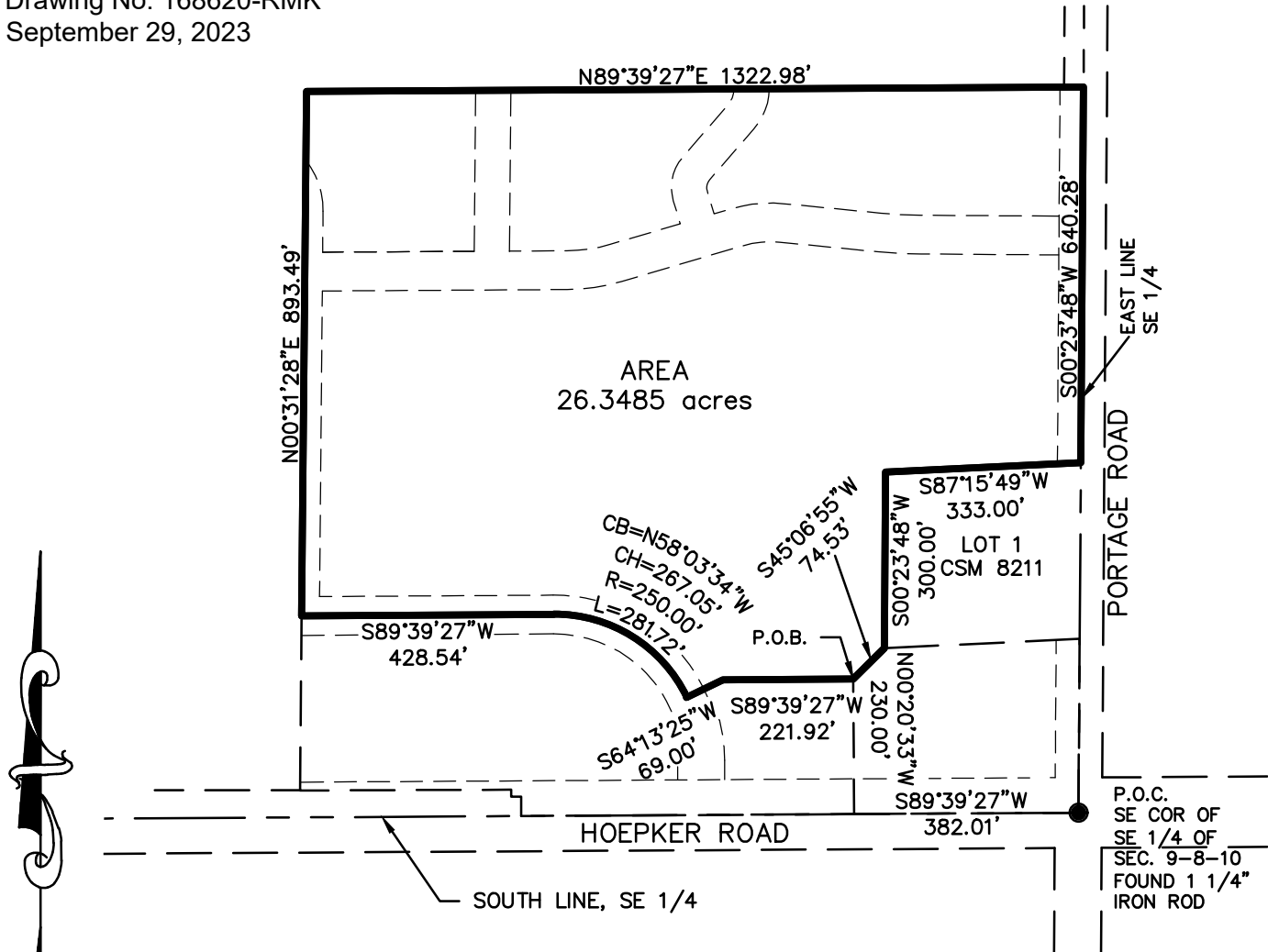
TR-U1 DISTRICT
