REOUEST

- 1. To approve a double sided, projecting wall sign, not to exceed 16 sf2.
- 2. To approve a projecting sign whose height does not exceed 25'-0" above grade. Please note: we are showing a height of 20'-6, however the grade is very steep on this block and we want to allow for any unintended variances.
- 3. To approve canopy letters (final design/location to be determined) for address identification.
- 4. To approve any necessary Parking Lot Regulation signs such as Handicap Parking, No Parking Fire Lane, Reserved Parking, etc. (any such signs will not exceed 24" x 18").






