Subject: Mowing of City Park Land

Dear Ms. Matranga:

It has come to my attention that you have mowed City park land that adjoins your property at Warner Park. It is a violation of Madison General Ordinances Section 8.15(1) to mow grass on park lands. Such mowing has been declared a public nuisance and each violation is subject to a forfeiture of up to \$500 dollars. With this letter, the City is hereby informing you to immediately cease mowing City park land, and that further mowing of Warner Park by or on your behalf will be met by citation or other enforcement actions.

You have the right to appeal this allegation of violation to the City of Madison Park Commission within 15 days after the mailing of this Notice. Such appeal must be in writing and must inform the Commission of the reasons why you believe this order has been issued in error. If you wish to appeal, MGO 8.15 specifies that the appeal be filed with the City Clerk at 210 Martin Luther King Jr. Blvd., Room 103, Madison, WI 53703.
