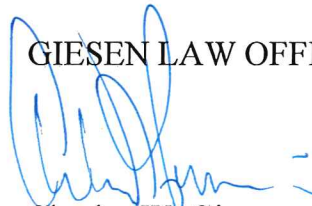

Dear Mr. Verbick:

This office represents North American Group of Companies, Inc., the liquor licensee for the premises located at 1901 S. Park Street.

It has recently come to our attention that the paper liquor license presently in existence for this location contains a condition that was included in error. Specifically, the license provides:

“4) The establishment shall not sell, dispense or give away intoxicating liquor in the original container in amounts of two hundred (200) milliliters or less in volume. . . .”

We have carefully researched the history regarding the granting of the license, including reviewing my notes from the May 25, 2017 ALRC meeting and preparing a transcript from the audio/video recording of the actions taken at that meeting pertaining to this license. The condition prohibiting sales of “200 milliliters or less” was discussed but was changed on motion to preclude the sale of bottles of 50 milliliters or less. With that change and the other conditions, the license was approved by the ALRC on May 25, 2017. A transcript of the portion of the ALRC hearing and vote regarding that condition is attached for your reference.

The Madison Common Council subsequently took up consideration of that license on June 6, 2017, and based on a motion by Alderwoman Rummel which was seconded by Alderman Baldeh, the Madison Common Council approved the recommendations of the ALRC. As noted, those only limited the sale of bottles of 50 milliliters or less. We are enclosing a transcript of that portion of the Common Council meeting for your information.

We would appreciate it if you could review these materials and provide our client with an updated and corrected paper liquor license that accurately reflects the recommendation of the ALRC which was adopted by the Common Council.

**Partial Transcript of ALRC Meeting 5/25/2017**

**Re: Item No. 16 (1901 S. Park Street)**

Mr. Fletcher: What I, I think, given what's been said about 11 and 19 being more similar, can we deal with 16 quickly? Can I make a motion?

Unknown person: Yes

Mr. Fletcher: Can I move that renewal with the conditions as read by the clerk, so the eight conditions I believe Rachel, and then maybe adding a ninth condition to deal with airplane bottles, which think is the 200 ml. language that's on another license if I'm. . .

Unknown person: 50 ml.

Mr. Fletcher: 50? Do we have standard. . .

[unknown persons speaking]

Mr. Fletcher: Do we have standard language on it that we typically, I think use right? I'm looking at Mr. Donnelly or the clerk . . .

[unknown persons speaking/laughing] Yeah . . .

Mr. Fletcher: Sorry about that.

Unknown person: It's in here for Rockies. . . .

Unknown person: Are you covering all three, is this gonna be for . . .

Unknown person: No, just 16.

Unknown person: Just 16. Okay.

Unknown person: Well you just have to change the number on it.

Mr. Fletcher: Oh, okay.

Unknown person: Because that's half pints.

Mr. Fletcher:        Okay.

Clerk:                So the condition, if you want, the condition for Rockies is: The establishment shall not sell, dispense or give away intoxicating liquor in the original container in amounts of 200 ml. or less in volume. Intoxicating liquor shall not include wine in the original container with an alcohol content of 15 percent or less.

Mr. Fletcher:        So change it to 50 . . . is that correct . . . the airplane? Okay. So we change that, we add a ninth condition with 50 ml. or less, and that Alder \_\_\_\_\_, you wanted a community meeting, is that correct?

[discussion about holding a community meeting, condition not necessary to be on their license . . .]

Unknown person:    Discussion? [pause] No discussion. All right, then we shall vote. All those in favor say aye. [Aye votes] Opposed? [none] Okay, so that's Item 16, and then you want to take 11 and 19 . . .
