As a resident living directly across the street at 241 Oak St, I have already noticed an increase use of street parking and an increase in the presence of intoxicated individuals since the introduction of Minocqua Brewing Company.

I am also very concerned about the planned addition of an outdoor beer garden. Despite the fact that this has not yet been approved, Minocqua Brewing Company has already started construction. I can verify that they have had several different equipment rentals for this purpose, as they park them in front of my house to load and unload.

Dear Members of the Plan Commission and Alder Martinez-Rutherford,

We are writing to express our strong opposition to the proposal to allow food trucks at the Minocqua Brewing Company Tasting Room, located at 2927 E Washington Avenue, as detailed in Legistar File ID #82947. We reside adjacent to this location and are deeply concerned about the potential negative impacts this development will have on our quality of life, property value, and neighborhood tranquility.

Harassment and Disregard for Neighbor Concerns

Minocqua Brewing Company's owner has already demonstrated a pattern of harassment towards us and other neighbors through social media, as shown in the attached screenshots. The dismissive and antagonistic comments made by the owner stand in stark contrast to their claim in the Letter of Intent for this project that "it is of the utmost importance to us that we are good neighbors and are responsive to the needs of the residents." This behavior sets a concerning precedent about how seriously the company takes community feedback and well-being. Additionally, the owner attempted to continue construction on the beer garden without a permit, exemplifying a troubling pattern of behavior.

Impact of Food Trucks on Residential Area

1. **Noise and Traffic:** The introduction of food trucks will inevitably increase noise and traffic, further disrupting our already affected neighborhood. The beer garden proposal has already led to increased vehicular and foot traffic, which compromises the safety and peace of the residential area.

2. **Zoning Concerns:** Our residence is zoned as Residential Transitional, which aims to maintain a balance between residential and commercial activities. The introduction of food trucks, which are considered a conditional use, further tips this balance unfavorably for the residents.
3. **Operating Hours:** Although the current proposal suggests limited hours, the potential for expansion is concerning. The proposed food trucks' operating hours will overlap with peak relaxation times for residents, leading to further disturbances.

Lack of Public Comment Opportunity

The beer garden development has been allowed as a "minor alteration to a conditional use," which bypasses the opportunity for public comment as directly noted in the final paragraph of the Staff Comments letter. This food truck proposal therefore represents one of the few chances for residents to voice their concerns formally. It is imperative that the plan commission consider the full breadth of community input during this decision-making process.

City Plan Commission Motto

We urge the Plan Commission to consider its own motto: "***Consider: Who benefits? Who is burdened? Who does not have a voice at the table? How can policymakers mitigate unintended consequences?***" In this scenario, it is clear that the primary beneficiaries are the business owners, while the burdens fall disproportionately on the residents. The voices of the local residents, who are most directly affected, must be given significant weight in this decision.


Conclusion

This development does not align with the community's needs and will significantly burden the surrounding residents.
