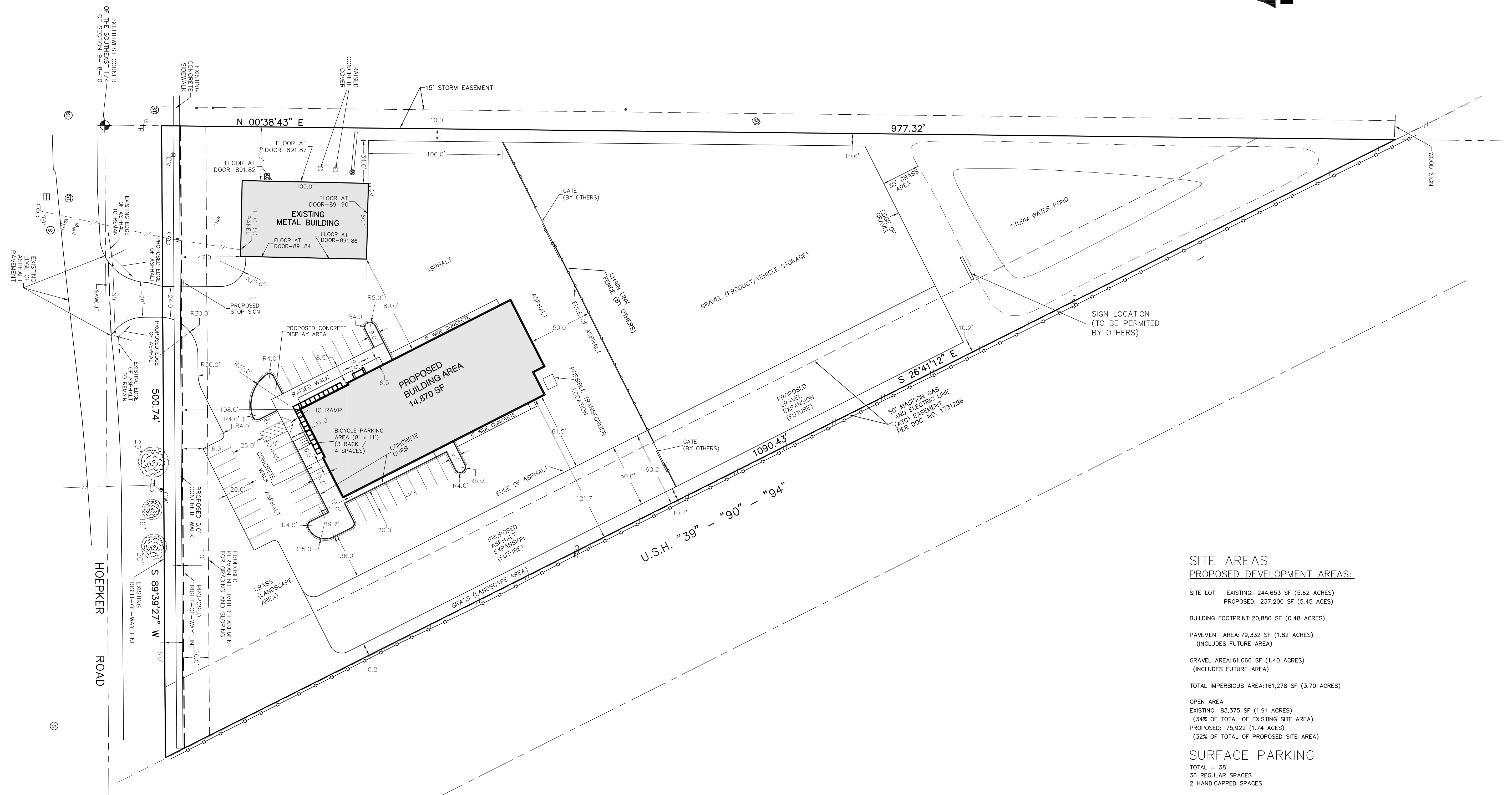

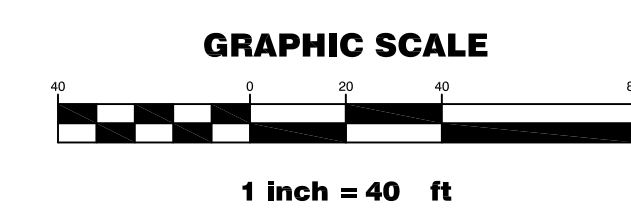


GRAVEL PAVEMENT
