Street Vending Coordinator's Report, including enforcement, activity, licensing and permitting numbers, the number of chairs in each sidewalk cafe

This may include references to the numbers of street vendors and sidewalk cafes licensed, TEM (Tabling) permits issued, enforcement activity, preparation for vending near Camp Randall during UW home football games, the amount of public electricity available to downtown food vendors, identifying alternative Langdon Street High Density Vending sites due to university construction, and the elimination of some Capitol Square 2016 food vendor sites due to construction and a new sidewalk cafe.

1. [39815](#)      Requiring LP-gas Detectors in all Food Carts  
An intern working for the Madison Fire Department conducted site visits to inventory the quantity of LP-gas used by most of the food vendors. With the inventory in hand, the Fire Marshall discussed related concerns with the Building Inspection Director and the Assistant Fire Chief. They agreed that the City should consider requiring LP-gas detectors in all Madison food carts. The detectors cost less than \$60. They asked that it be added to the August 26th VOC agenda.
