A BILL

- To prohibit the sale of certain inefficient light bulbs, and require the development of a plan for increasing the use of more efficient light bulbs by consumers and businesses.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. PROHIBITION.
 - 4 (a) REGULATIONS—Not later than 1 year after the
 - 5 date of enactment of this Act, the Secretary of Energy
 - 6 shall issue regulations—

- 1 (1) prohibiting the sale of light bulbs that emit
- 2 less than 60 lumens per watt, effective January 1,
- 3 2012;
- 4 (2) prohibiting the sale of light bulbs that emit
- 5 less than 90 lumens per watt, effective January 1,
- 6 2016; and
- 7 (3) prohibiting the sale of light bulbs that emit
- 8 less than 120 lumens per watt, effective January 1,
- 9 2020
- 10 (b) EXEMPTIONS—The regulations issued under
- 11 subsection (a) shall include procedures for the Secretary
- 12 to provide exemptions to the prohibition. The Secretary
- 13 may provide such an exemption only in cases where the
- 14 Secretary finds, after a hearing and opportunity for public
- 15 comment, that it is not technically feasible to serve a spe-
- 16 cialized lighting application, such as a military, medical,
- 17 or public safety application, using bulbs that meet the re-
- 18 quirements of subsection (a) Exemptions provided under
- 19 this subsection shall expire after 2 years. No exemption
- 20 may be provided under this subsection for general illu-
- 21 mination applications.
- 22 (c) CIVIL PENALTY.—The Secretary of Energy shall
- 23 include in regulations under this section a schedule of ap-
- 24 propriate civil penalties for violations of the prohibition

- 1 under this section. Such penalties shall be in an amount
- 2 sufficient to ensure compliance with this Act.
- 3 (d) DEFINITION —For purposes of this Act, the term
- 4 "general illumination" means lighting designed to provide
- 5 a substantially uniform level of luminance throughout an
- 6 area exclusive of any provision for special or local require-
- 7 ments
- 8 SEC. 2. PLAN.
- 9 Not later than 6 months after the date of enactment
- 10 of this Act, the Secretary of Energy shall transmit to the
- 11 Congress a plan for encouraging and providing incentives
- 12 for the use of more efficient light bulbs by consumers and
- 13 businesses.
