I write in opposition to the repeal of Section 6 of the Unlawful Trespass code of the City of Madison.

I strongly support the recommended amendment to the city's general ordnance 23.07. The primary reason for my support is the current ordnance adds two subsections to the trespassing ordnance that are directed primarily at the unhoused population, a protected population in the City of Madison, for additional monetary forfeitures. Currently, under subsection 6, sections (a) and (b) the ordnance states that (a) no person shall sleep, lie down, or take temporary habitation on the property of another without permission of a person lawfully on the premises; and (b) no person shall possess or use items commonly associated with sleeping or habitation including but not exclusively beds, mattresses, sleeping bags, bedrolls, blankets, pillows, sheets, quilts, and comforters on the property of another person without permission of a person lawfully upon the premises. Under the current trespassing ordnance police can issue multiple tickets to a protected class with limited means for one (1) event.

Trespassing is and will remain illegal but the ability to financially oppress a group of people who are already financially unstable will be removed.

Dear Alders,

I am writing on behalf of JustDane to express our agency's support of item 44. (79504) on this evening's Council Agenda. The substitute amending Section 23.07 (2) and repealing MGO 23.07 subsections (6)(a)(b) of the trespassing ordinance. Those sections of the ordinance are antithetical to Madison's recognition of homelessness as a protected class within our Civil Rights code. The behaviors outlined in subsection (6) (a)(b) single out individuals who are in possession of any items used for sleeping, as well as the behavior of sleeping or lying down. Subsection 6 appears to directly target individuals who may be unhoused and subjecting them to additional fees under the trespassing ordinance. Trespassing is typically defined as unlawful entry onto someone else's property - the actual behavior the person is engaging in, for example sitting on the ground playing a guitar vs. laying on the ground sleeping, doesn't matter, if the person doesn't have the owners permission, the person is trespassing. The current ordinance singles out certain behaviors more likely to be engaged in by unhoused individuals and allows for additional penalties, this is discriminatory in practice and further criminalizes homelessness through the additional fine - the general fine for violating Section 23.07(2) would apply to all individuals who trespass.

While we understand that not everyone may feel comfortable or safe directly asking someone to leave their property, the proposed revision to Subsection (2) of Section 23.07 allows the property owner or occupant to authorize another individual (including police) to notify the individual not to enter or to vacate the premises. This amended language in Subsection 2

recognize that the definition of trespassing relates directly to an individual being on a property without consent of the legal occupant or owner, without parsing out specific behaviors for additional stigma and fines. We urge you to vote in support of Item 44, amending Section 23.07(02) and repealing Section 23.07(6) and amending Section 23.07(13) and 1.08 of the Madison General Ordinances to remove associated references.
