423 W Mifflin Street

• Two-unit residential building constructed in 1890.

• This structure was constructed in 1888 by Charles Gruendler, a carpenter. Designed to be a two-unit structure, this originally housed working-class professionals. This typical style of what is now known as Missing Middle Housing is typical

of the Mifflin neighborhood.

427 W Mifflin Street

Four-unit residential building constructed in 1929.

• This four-unit English Revival multi-unit residential structure was built in 1928 and designed by noted Madison architect, Ferdinand Kronenberg. In reviewing the <u>original plans for the structure</u>, available in the <u>Kronenberg archival collection</u>, shows that this building retains excellent historic integrity. The house was originally the home of Anton (a plumber) and Marie Metz and their children. In addition to being a work of a noted architect, this building also serves as evidence of working-class

professional housing in the early 20th century.
