Jazz at Five plans for 13 volunteers, minimum each night.


- 7 volunteers are assigned to the perimeters (top of State 100 blk, bottom of State 100 blk, Carroll Street cul-de-sac & Mifflin cul-de-sac.) They are there to greet, assist and answer questions and also to ensure that no alcohol is carried past the event perimeter.
- 7 city barricades are set. 3 top of 100 blk. of State, 2 bottom of State, 2 on either side of the Mifflin Street cul-de-sac.
- Signs are posted on these barricades no carry-in alcohol, no alcohol past this point, please walk your bike. Pre-show, intermission and post-show announcements are made w/reminders of these rules.
- Our information booth serves as location for anyone to report a problem and houses a first aid kit.
- Jazz at Five has never had to call upon City authorities or medical personnel, but would
  do so if needed and will ensure that the 21' access is maintained within our event set-up
  should they need to access the 100 blk. of State by vehicle.
