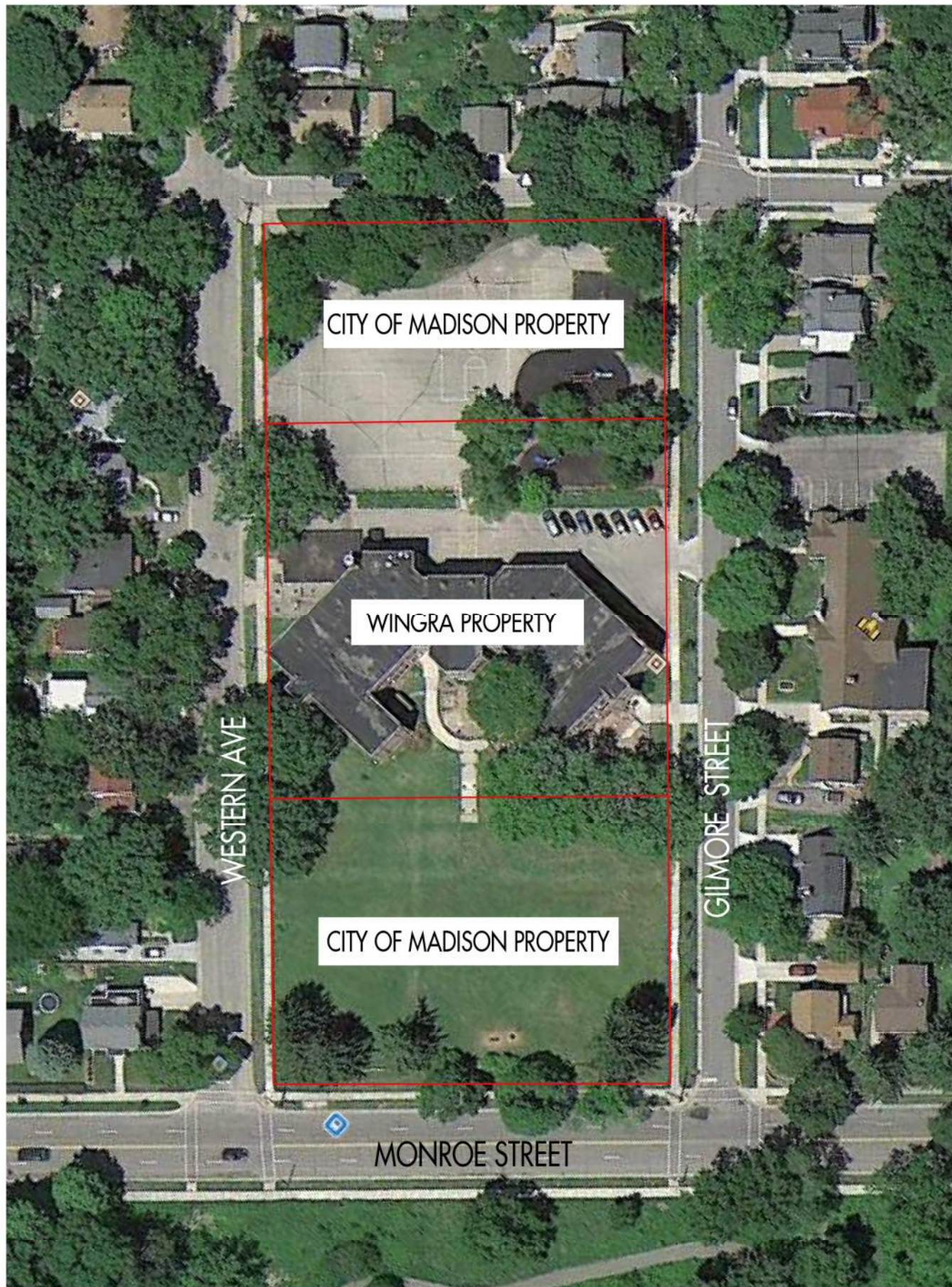

Project Description

Wingra School is proposing a small addition to their existing building at 718 Gilmore Street. The addition is intended to improve the accessibility of the facility, consolidate administrative functions in a single area, and provide a supervised entry sequence.

Wingra School has been located in the existing facility since the 1970s, when the Dudgeon School was decommissioned and turned into the Dudgeon Center for Community Programs. In 2007, Wingra School purchased the building from the City, and has been working towards this addition since that time.

SITE LOCATION MAP

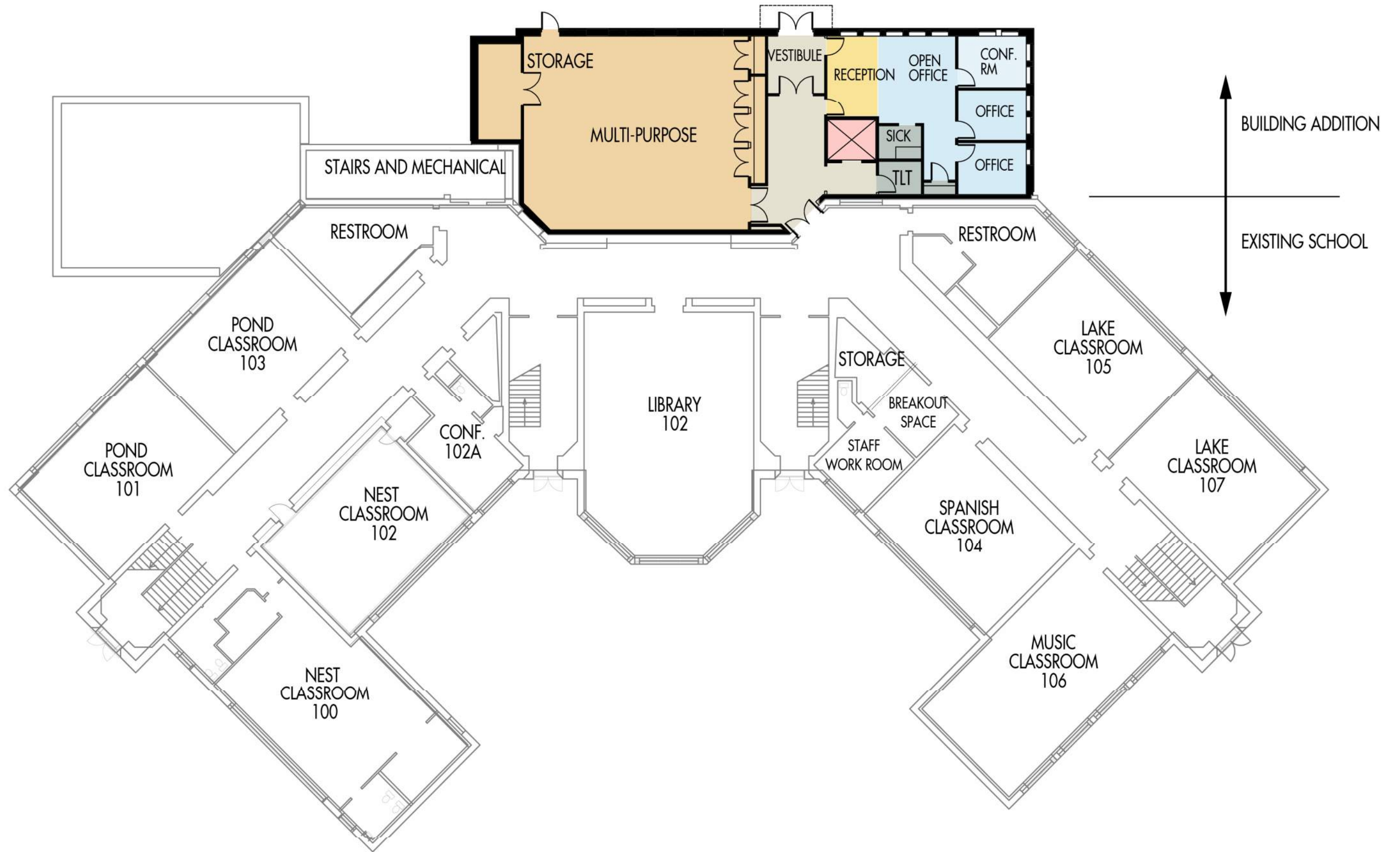


PN TN 0 20 40 80' SITE PLAN

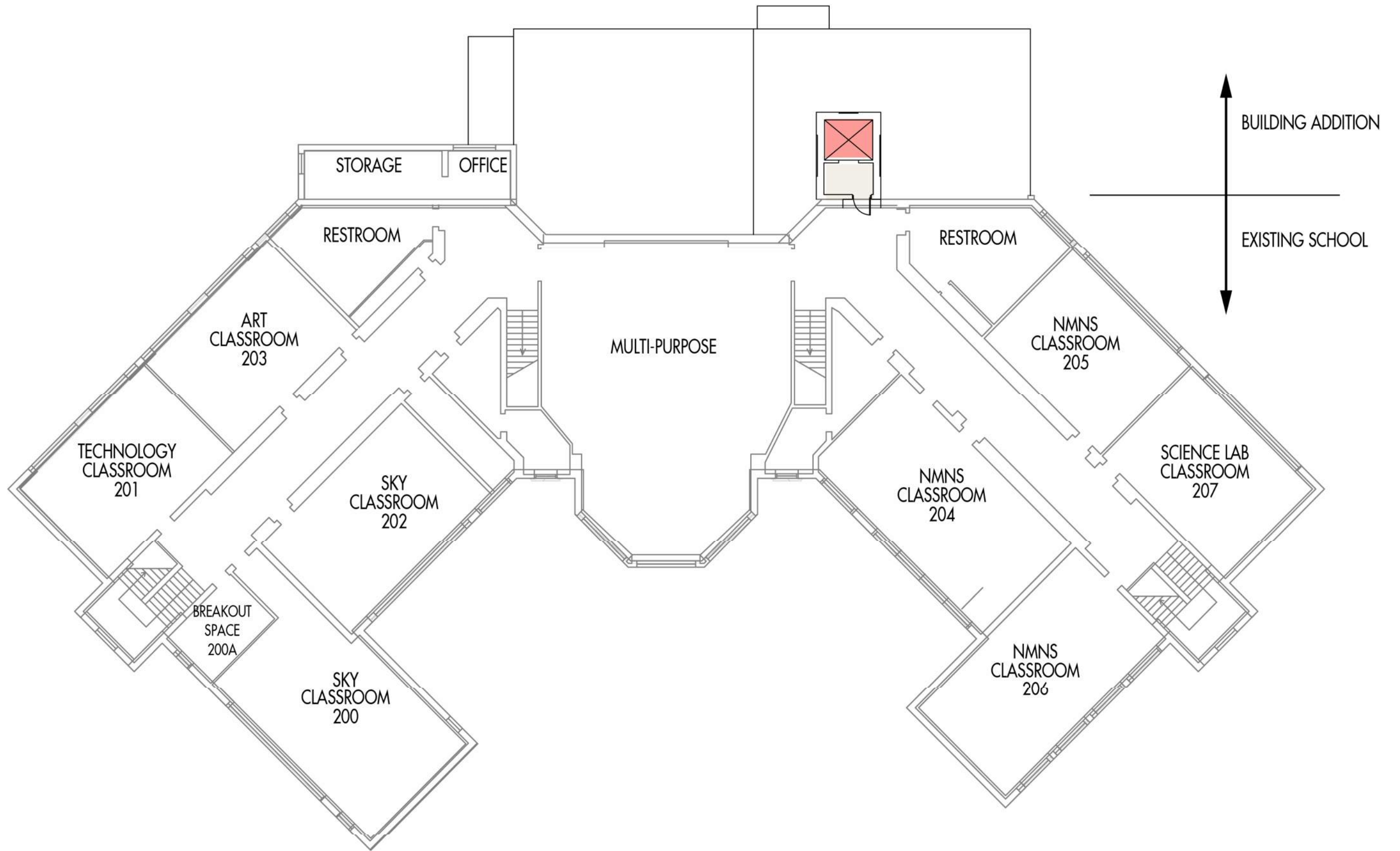

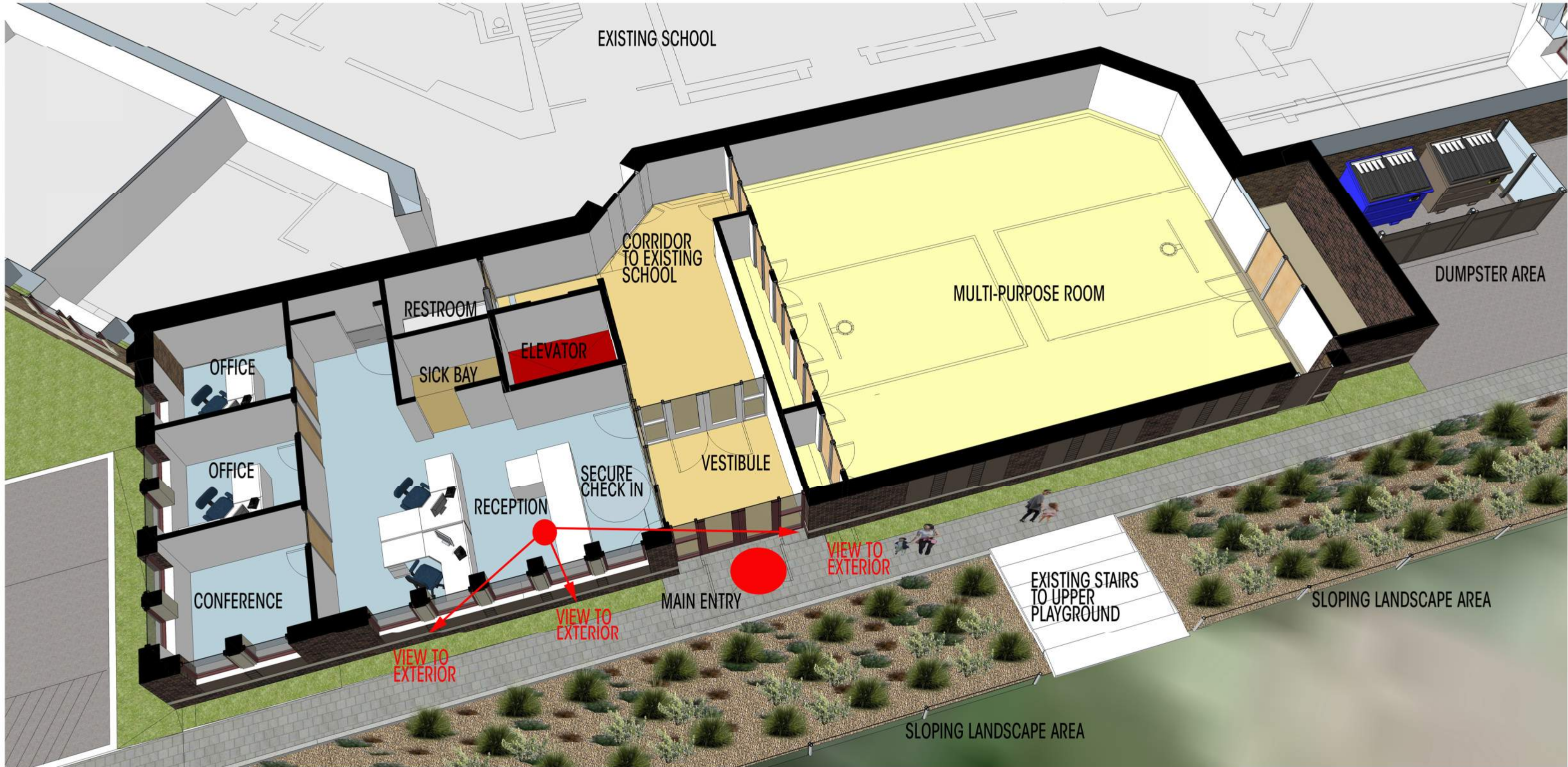
