This item was approved as a consent item with the finding that all applicable standards are adequately addressed and with all the staff recommendations contained in the report.

A motion was made by Bernau, seconded by Braun-Oddo, to Grant Final Approval. The motion passed by voice vote/other.

## **UNFINISHED BUSINESS**

5. 66561 555 W. Mifflin Street - New Development in UMX Zoning. 4th Ald. Dist.

The motion provided for the following:

- Consideration of a more shade-tolerant plant in lieu of the Blue Star Junipers (Yew, Hemlock, Hostas, some large ferns); Honeysuckle vine (Lonicera) in lieu of Boston Ivy; and Tor Burch Leaf Spirea in lieu of the Gold Flame Spirea.
- · Maintain the third floor loft area window in the bathroom and add a transom at the balcony.

A motion was made by Braun-Oddo, seconded by Klehr, to Grant Final Approval. The motion passed by voice vote/other.

6. 68057 30 Ash Street & 2330-2436 Regent Street - Public Building, Alteration to Approved Conditional Use(s) to Consider a Revised Approval Condition to Allow the Removal of an Existing Retaining Wall and Landscaping Features. 5th Ald. Dist.

An original motion was made by Bernau, seconded by Knudson to advise denial of the proposal. Firchow noted that the Commission is an advisory body on this request. The motion to deny failed on a roll call vote of (4-3) with Knudson, Bernau and Klehr voting to deny; Braun-Oddo, Albouras and Harper

voting in opposition to denial, and DeChant voting to deny to break the tie. The motion of (4-3) failed for lack of five votes to pass. A subsequent motion was made by Braun-Oddo, seconded by Albouras to approve the concept but asking the design team to consider a different material for the wall that would be equitably priced for the district but be less suburban looking and more appropriate for a city school. The motion failed on a roll call vote of (1-5) with Braun-Oddo voting yes; Bernau, Knudson, Klehr, Albouras and Harper voting no.

The Commission did not pass a motion on this item.

#### **NEW BUSINESS**

7. 67494 804 Felland Road - Residential Building Complex. 3rd Ald. Dist.

The motion was approved subject to the following conditions:

- -Provide landscape alternatives to the Callery Pears, Acer Ginnala Amur Maple and Acer Tarari Maple with other small ornamental trees and replace Stella D'Oro Daylilies with other perennials.
- Provide simplification of the prairie style building to better match the modernity of the others.
- Provide simplification of colors including of where colors transition.
- Create additional on-site greenspace in the townhome lots (3 and 4).

A motion was made by DeChant, seconded by Klehr, to Grant Initial Approval. The motion passed by voice vote/other.
