Moxy by Marriott Madison Downtown LICLIB-2023-00742 Amended Premises Description

The premise is an 8 floor, 151 room Moxy by Marriott hotel. The first floor of the hotel will feature the lobby, signature Bar Moxy, and lobby pantry selling prepackaged food and beverages. Alcohol will be sold and served from the Bar Moxy on the 1st and 2nd floors, in the pantry, small outdoor seating patio and walk-up window. Liquor will be stored in the bar area on the 1st floor and in a locked closet/cage that only the Manager has access to. Receipts will be stored in the General Manager's office on the 2nd floor. Food will be served from the lobby bar.

Not included in the premises is the 8^{th} floor restaurant and meeting space that will be leased and operated by a 3^{rd} party. This space will be licensed separately.
