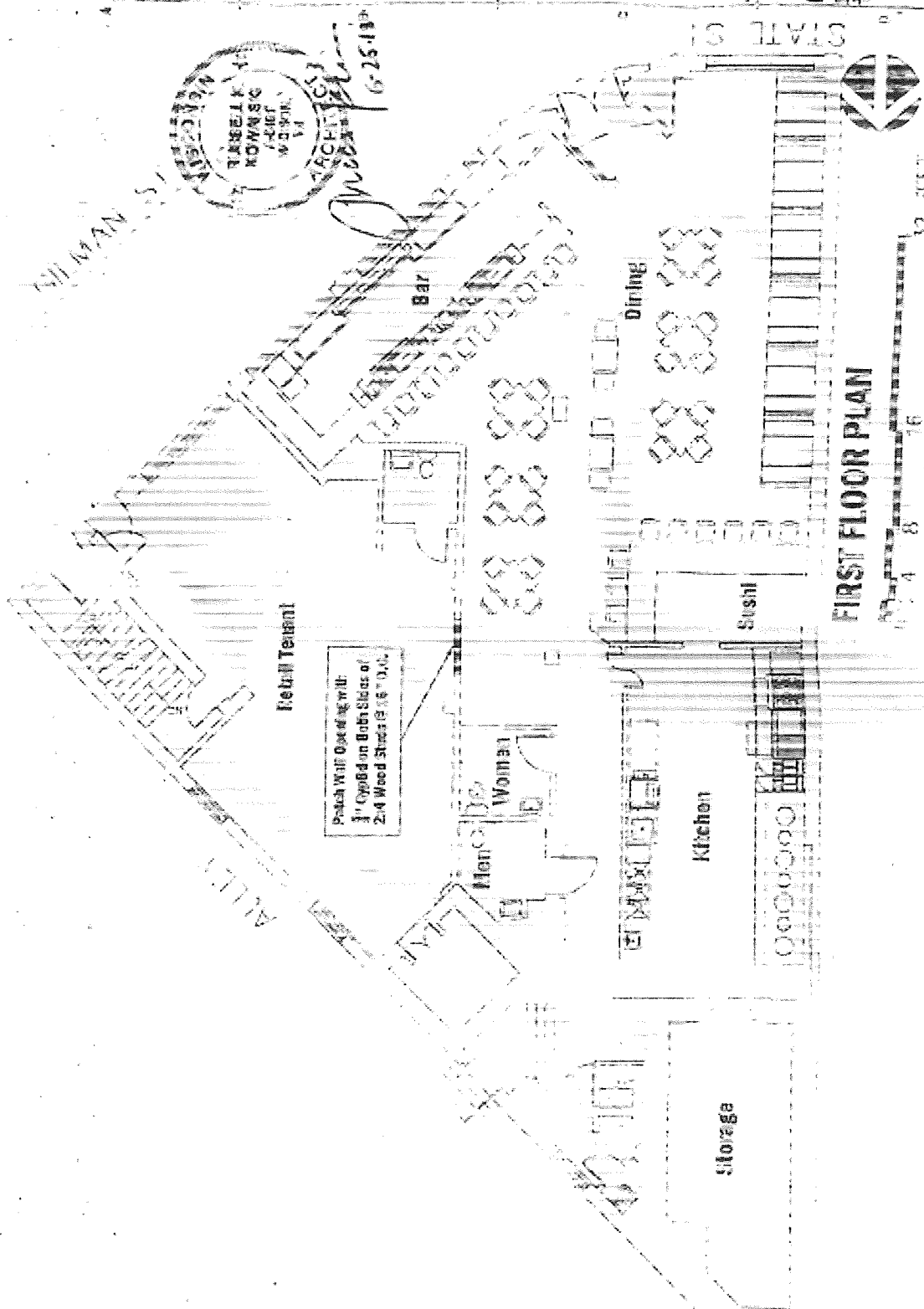

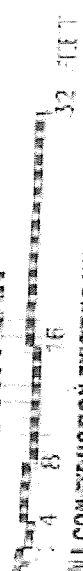

## 1.0 EXECUTIVE SUMMARY

The purpose of this plan is to lay out the future operations of Sookie's Veggie Burgers at 502 State Street, Madison WI 53703 for the review of the landlord(s) and/or building owner(s) of the property.

### 1.1 The Restaurant

Sookie's Veggie Burgers is a 100% plant-based fast food restaurant concept that will serve veggie burgers, baked fries, and "Sookies" (all-original drinks in-between a shake and a smoothie).

Additionally, plant-based versions of common fast food items such as chicken nuggets and milkshakes as well as waters and sodas will be sold.

### 1.2 Financing

Mr. McCune will raise \$227,000 from a SBA guaranteed loan (decision in early December 2021) through WWBIC, contributing 10% from personal finances.

Mr. McCune has arranged for the purchase of the business's food trailer for additional working capital.

Mr. McCune will receive an additional \$10,000 from the "Main Street Bounceback Program" <https://wedc.org/programs-and-resources/mainstreet-bounceback-grants/>

### 1.3 Mission Statement
