Guest Speaker. [Bjorn Claeson <http://www.sweatfree.org/leadership_staff>](http://www.sweatfree.org/leadership_staff/), Executive Director of [SweatFree Communities <http://www.sweatfree.org/about_us>](http://www.sweatfree.org/about_us) will present an overview of the mission, activities and services offered by the [Sweatfree Purchasing Consortium <http://buysweatfree.org/>](http://buysweatfree.org/). The Consortium is a collaborative project of governments, doing together what each public entity has already committed to doing, but no single public entity can do adequately alone: *ending purchasing from sweatshops.*

Guest Speaker Bjorn Claeson, Executive Director of SweatFree Communities spoke via speakerphone

- a. Bjorn Claeson started the presentation with background information on SPC's mission to "end public purchasing from sweatshops and help its members to make sweatfree purchases more effectively than any single entity could accomplish on its own."
- b. He proceeded to elaborate on the Consortium's purpose to serve as a resource and forum for collaboration for public purchasing entities and organizations that share the same goal.
- c. He discussed the benefits of membership with the consortium:
 - 1) Access to monitoring resources and factory information at a much reduced cost,
 - 2) Policy implementation assistance,
 - 3) Achieving greater impact through collaboration and joint policy of enforcement.

Bjorn responded to questions posed by committee members with regards to Dept. of Labor's activities in identifying non-compliant factories overseas, factory database and designated items list for cooperative purchasing, expanding the intent of the sweatfree policy beyond textiles or garments, independent monitoring contract with CREA, Inc. recently awarded through a competitive procurement by State of PA. - d. Recommendations for next steps:
 - 1) Further define the City's fair wage requirement as stated in MGO 4.25, Sec. (4) (b) 1, Wages and Benefits. Refer to City of Milwaukee's Non-poverty Wage Table (Exhibit 1) for context.
 - 2) Further define evidentiary standards for verifying information submitted by vendors to be used for awarding contracts.
 - 3) Designate a liaison for the Committee to participate in the Consortium's activities (anyone engaged in Procurement, labor compliance or sweatfree committee activities)

No formal action was taken on this item.

10. [18364](#) Discussion regarding prioritization of future plans of the Committee on Sweatfree Purchases for 2010

Agenda items for next meeting:

- a. Recommend creating a resolution to authorize membership by City of Madison in the Sweatfree Purchasing Consortium and appropriate \$500 for initial dues and an estimated \$1000 for future annual dues. While a resolution is not required for such action, the formal process would be appropriate to draw attention to and recognize the City's work in promoting humane/ethical government purchasing. Ask the Mayor to sponsor the resolution.
- b. Designate a liaison for the Sweatfree Purchasing Consortium to represent the City committee.
- c. Learn from other Cities about how they administer these standards. Invite City of Milwaukee and MPD (Madison Police Dept) for a brief overview/discussion of their experience and process of contracting for uniforms.
- d. Standing update on Sweatfree Purchasing Consortium activities.

Continuing discussions:

- e. Clarify ordinance and/or adopt guidelines to further define the meaning of fair wage or non-poverty wage, as applicable to other countries. Evaluate ordinances of other cities (e.g., City of Milwaukee, New York, San Francisco, etc.) for reference.
- f. Provide for a mechanism to employ evidentiary standards for verifying information submitted by vendors to be used for awarding contracts.
- g. Continue discussion of ordinance in the broader context to develop a more coherent and effective policy.
- h. Explore other related cooperative contracts available, e.g. San Francisco's effort to lead a competitive procurement for uniforms.
- i. Staff to notice and forward to the committee, scheduled monthly Sweatfree Purchasing Consortium teleconference meetings.
- j. Invite UW to explore both shared knowledge base and differing tracks related to anti-trust or wage issues, as well as find avenues for collaboration.
