OCS has distributed a budget memo to Community Resources agencies that included a calendar outlining committee budget meetings/hearings.

Parker confirmed that the City departments must also cut 6% of their operating budgets.

Funding Scenarios for 2010

**ECCEC Priorities** 

Staff provided handouts to the group. The first document outlined the ECCEC's 2009-2010 funding priorities, adopted by Council in 2008. The second listed the 2009 funding allocations by priority. The last one was a summary of possible funding scenarios for the budget cut of 6% if the Committee chooses to follow its 2009-2010 funding priorities resulting in reductions to A-3 programs to reach the needed reduction of \$52,362.

Parker inquired about what percentage of a given program does the City fund. This information could assist with cut decisions. Bidar-Sielaff stated she would

like to have more funding information to assist in evaluating the impact of cuts and stated it would be helpful to know what programs will be receiving stimulus funds.

Staff reminded the group that this is the second year of a two year process and that the Committee has previously established its funding priorities.

Brown added that there were problems in the past when A-2 programs were cut over A-3 programs. Council made it an issue and overruled the Committee's decision.

Clingan reminded the group their budget recommendations would be submitted to the Mayor on August 7 with eventually Common Council having authority to make final budget decisions.

MOTION by Parker, seconded by Schultz that preliminary 2010 funding recommendations will consist of a 6% across the board cut to all programs. Motion passed by voice vote with Jacob voting no.
