Dear Director of Public Health,

I am Comazel Caldwell, I am writing to request an Administrative Review based on the fact that the report written by Ms. Meyers is a great piece of "Fantasy" with very little truth or fact in it.

Let's start with the 12/2/21 incident: Ms. Meyers report states that Petra attacked another dog when the dog got near Petra's ball. When in fact the other dog was not just one dog as Ms. Meyers would lead you to believe, but three Malamute dogs who took Petra's ball and then proceeded to attacked Petra when she went to get her ball back. The owner of the three Malamute can not honestly say which dog bit her when she had three dogs biting and I only had one. But of course, the source for her wound would never be her dogs.

I want you to take note of the omission of the fact that there were three Malamutes dogs and not just one.

On 6/15/21 at the Capital Springs Dog Park: there was no lady biting by Petra, but fact a lie that she had been bitten. I asked Ms. Meyers to look at the evidence to see for herself if in fact the lady was lying. I begged Ms. Meyers for months and months and months to look at the evidence, but she refused to. I asked her again at the Zoom Conference to look at the evidence. This time after the conference she details finally looked at the evidence and told me at our home visit that the lady had not had any skin broken and received no medical treatment and was not bitten. And as soon as Petra entered the park she was attacked by one of the dogs in there. Petra was injured and bleeding and if you ask that witness today I'm sure she will remember.

On 9/29/20 at Sycamore Dog Park: I notice that Ms. Meyers report is once again omitting valuable details. The first being the fact that Petra was attacked as soon as she entered the dog park. The second fact omitted by Ms. Meyers was the fact that Petra was attacked before I even had a chance to close the gate or take Petra's lease off. Fact Number three that was also omitted from the report by Ms. Meyers was that the dog that attacked Petra was a very large Pit Bull Terrier almost twice her size. Petra was bleeding in a few places and no harm to the Pit Bull. The Madison Police department was called and a report was made. The lady that owned the Pit Bull was injured when she stepped between the two biting dogs. That lady made no attempt to grab her dog. I had never let go of Petra, because she was still on her lease and I was pulling her away as the Pit Bull kept coming forward. The statement that the lady made to Ms. Meyers was that her dog was messing around down by the gate. And none of that was put in the report by Ms. Meyers. I mean "How can you not mention a Pit Bull attacking a smaller dog?"

And Ms. Meyers is trying to "Brand" my dog as dangerous. Should I quote the number of Pit Bull attacks in the United States? If Ms. Meyers is an example of what the Animal Control department for the city of Madison looks like I want my tax dollars BACK.
