ZONING CODE REWRITE SPECIAL MEETING

ZONING CODE REWRITE

<u>15932</u>

Adopting and confirming amendments to the Madison General Ordinances as set forth in attached Exhibit F pursuant to Sec. 66.0103, Wis. Stats. to revise the City's Zoning Ordinance.

This Ordinance was Rerefered to the PLAN COMMISSION.

Ald. Satya Rhodes-Conway provided an overview of her interest in "transformational zoning" and asked the Plan Commission to consider the following questions:

- For new development: Which districts, and thus what forms, do the Commission not want to be applied in these areas?
- 2. For existing development: What commercial building forms does the Commission want to see change over time, and if applicable, are changes best made through the zoning text or through the zoning mapping process?

3. For existing development: Are there residential areas that the Commission wants to see change over time?

A discussion on these questions followed.

A motion was made by Kerr, seconded by Sundquist, to request that staff assess recently completed neighborhood development plans to see if any of the adopted plans include areas that could be zoned in the following districts: CC-T, CC, SE, SRC1, and TRR. The motion passed by voice vote/other.

The next regularly scheduled Plan Commission meeting will be on October 18. The Plan Commission will hold Zoning Code Rewrite special meetings on October 25 and October 26.
