CALL TO ORDER

Chair Bremer called the Board meeting to order at 4:32 p.m. following verification by the Secretary that the meeting was properly noticed and a quorum was present.

PUBLIC HEARING - FIBER OPTIC INSTALLATION

Vice Chair Clausius called the public hearing to order at 6:31 p.m. following verification by the Secretary that the Meeting was properly noticed and a quorum was present.

Attendance: Vice Chair Clausius, Mr. Bremer, Alder Palm, Mr. Rewey

Members Excused: Mr. Harrelson, Ms. Hewitt, Mr. Elmakias, Alder Van Rooy, 1 Vacancy

Vice Chair Clausius opened the informational hearing item:

Henshue Construction, Inc. cable installation contractors hired by Lokre Data Center, LLC will
install the buried fiber optic cable within the roadway/bike path/railroad limits at the following
locations:

Mr. Gary Henshue, representing Henshue Construction addressed the Board and reported that this project is to install fiber optic cable within the roadway/bike path/railroad limits along the following route:

South Bassett St. from W. Main to railroad tracks (SE end of S. Bassett St.); Across N. Shore Dr. at the intersection of John Nolen Dr.; Along the west side of John Nolen Dr. from N. Shore Dr. to the intersection of the WSUP RR.; & on City of Madison owned ROW and City owned land along the Isthmus Bike Path from Blount St. to S. Marquette St.

Restoration of any damage within the limits of the road row will be completed in accordance with the City of Madison's Standard Specifications. All damaged sidewalk slabs will be replaced with a 5" lift of concrete. All damage done to grass between sidewalk and curb or along the bike path will be restored with a 4"covering of black dirt and seed. All restoration required within the traveled portion of the roadway will also be completed in accordance with the City of Madison's Standard Specifications.

He stated that the length of the project is 11,700 feet of which 7,500 feet will be bored, and the remaining 4,200 feet will be plowed. The directional boring will be done in the terrace in City right-of-way.

He stated that Henshue Construction distributed over 200 flyers to the surrounding residents and no one had contacted him with objections.

Mr. Rewey expressed concerns that the bike paths not be disturbed.

Mr. Henshue responded that there is no indication that the bike path(s) would be affected, the project is to be done next to the pathways and should not disturb them.

Ms. Bachmann with City Engineering also stated that if calls are received relative to disturbing the bike paths, an inspector would immediately be sent to the work site and enforce the permit boundaries.

There were no registrants present; Vice Chair Clausius closed the public hearing at 6:42 p.m. and noted for the record that no action was required by the Board. City Engineering would proceed with the permit approval process.

SUBSTITUTE - To establish and execute a fair and participatory process for deciding whether or not and/or how to restrict the flow of motorized vehicular traffic on Edgewood Drive, a remnant of the Park and Pleasure Drive system. The process includes public information, citizen participation, attorney analysis, traffic engineering analysis, consultation with the Edgewood schools and the other abutting property owner and, finally, consideration by the Common Council of any restrictions recommended by the Board of Park Commissioners.

A motion was made by Ald. Van Rooy, seconded by Mr. Clausius, to Return to Lead with the Recommendation for Approval to the BOARD OF PARK COMMISSIONERS

Mr. Bill Barker, President of the Park Commission addressed the Board and expressed appreciation for the work expended by Mr. Nelson to bring this issue to a resolution. Mr. Nelson developed a plan to cul de sac Woodrow Street to resolve the traffic problems.

The Park Commission, affected alder, neighborhood associations and residents all support this solution. It was reported that there would be no problem with any encroachment into the bike path area.

The motion passed by acclamation.

Authorizing the Mayor and City Clerk to execute the Green Tier/Clear Waters Initiative Environmental Results Program Charter pursuant to Section 299.83, Wisconsin Statutes. (City-Wide AD)

A motion was made by Mr. Rewey, seconded by Ald. Palm, to RECOMMEND TO COUNCIL TO ADOPT - REPORT OF OFFICER Mr. Nelson reported that Section 299.83 of the Wisconsin Statutes provides voluntary methods that can be used and improved to minimize and prevent stormwater runoff problems associated with land development, and home building construction site activities. The City of Madison, City of Sun Prairie, Veridian Homes, Dane County, and the Wisconsin DNR have developed a "green Tier Charter" to accomplish specific objectives. He explained that the Statute will allow for self-enforcement by developers on site, to adhere to erosion control measures. He was glad to see this cooperation.

The motion passed by acclamation.

Plans were displayed for this project, and Mr. Nelson reported that this is a joint redevelopment of this area in hopes to regenerate the Arbor Hills neighborhood. In order to made the area more attractive it was important to address transportation, pedestrian, bus stop, and signal requirements. The undergrounding of the utility work will be done as a separate agreement because of funding.

Alder Bruer then expressed his appreciation to City staff and Mr. Nelson for expending the time and effort to take on this redevelopment.

It was reported that the estimated cost is \$9,216,800 of which the City's share is \$908,800.

It was reported that this item will require a Notice of Intent from the DNR for disturbing land greater than one acre. The Department of Transport; ation is responsible for obtaining all permits.

Mr. Bremer resumed the Chair following the Board action on this item. The motion passed by acclamation.
