

Historic Log Cabin and Early Learning Garden Deck

Outdoor Exhibits:

In order to provide outdoor exhibit space at street level, the Madison Children's Museum proposes to construct two exhibits to complement it's new facility: a small historic log cabin, fully restored, to be located in an existing landscaped area of the parking ramp, and; a raised garden deck located over an existing planter that flanks the Hamilton Street entry to the parking ramp.

Operation:


Madison Children's Museum intends to operate the historic cabin and garden deck as year-round exhibit environments. In most cases, the cabin and deck will be open to museum visitors during normal operating hours; the only exceptions will be extended hours when the museum is open for special events or infrequent closings during extremely inclement weather.

Access:

The Museum's Visitor Services staff will monitor and maintain a safe environment in and around the historic cabin and garden deck. Individual visitors will be accompanied by parents, caregivers or staff during their explorations. The garden deck will be accessed directly from the new early learning exhibit space via a new glass door (per previous approval). School group visiting the cabin will be accompanied by museum staff at all times. Clearly marked pathways will guide visitors to the cabin from the parking lot entrance and/or the museum's second entrance, located within the parking lot. All routes are fully wheelchair accessible.

Security:

The cabin and the gate surrounding its site will be securely locked when the museum is closed. Security lighting will provide additional protection. There is no access to the garden deck from the street/parking lot level.




Photo of the recently restored Gotten Cabin ~ very similar to Madison Children's Museum's historic 1838 log cabin
