Doug,

This e-mail will confirm that if the City of Madison Plan Commission is interested in having you install a sidewalk (curb & gutter) along the east side of Woodrow Street, the City would need to apply to the Director of the Wisconsin Historical Society (with a copy to me) to disturb a catalogued burial site (i.e. the effigy bird mound) and a portion of the uncatalogued burial site. As you know, the current catalogued

boundary of the mound extends west into the area of Woodrow Street. The application process, including notification to those on the Registry of Interested Persons (for the catalogued mound), could take several months. If either the applicant (the City), or anyone on the Registry requests a hearing on the matter, the process could take additional time.
