

Madison Parks Commission,

The Demetral Grass Volleyball tournament on June 6<sup>th</sup> will be a fun athletic activity involving adults and junior athletes. We plan on setting up about 25 grass volleyball nets and boundary lines to hold the tournament in the baseball outfields. The tournament is 3 versus 3 and is not like normal indoor 6 versus 6 volleyball.

The tournament will include volunteers grilling out typical summertime food on a few grills near the permanent structure. There will also be water and other non-alcoholic beverages sold in this area. We plan on setting up a beer garden area that is fenced in with typical 4foot high orange temporary construction fencing. There will be a designated entrance and exit with a person checking ID's. Wristbands will be given to approved 21+ people that are in the beer garden drinking area. Beer will be sold for \$2 a glass and we are using 10 OZ plastic containers.

We will have a small PA announcement area where we will make announcements of courts and who is playing where. We also will have low level music playing for portions of the day. We will have volunteers around all day organizing the kitchen area, cleaning up the trash and making things run smoothly. I am planning on renting 3 portable restrooms and 8-9 trash cans to place throughout the park to keep the area clean and to make final cleanup easy. We have a group of parents assembled that will help cleanup the park at the end of the day so that it looks like it did when we set up Saturday at 4am.

Set up will take place Saturday morning at 4-5am and take down will happen after the tournament from 7-9pm. Spectators can watch the tournament for free and enjoy all that we have to offer!
