Hello!

My name is Cait (Shanahan) Sirianni and I am submitting an entertainment license application for Crescendo LLC, dba Crescendo Espresso Bar and Music Cafe at 1859 Monroe Street, Madison. We currently hold a Class B Beer and Class C Wine license.

Our security plan is as follows:

During events we have no less than 2 and up to 5 people working, all of whom have applications with personal information on file. I, The Liquor and Beer Agent/Owner, am present at every event and more often than not my husband as well. Our events are paid entry with someone working at the door. The person at the door is responsible for checking ID's and paying attention to intoxication level (if any) of patrons upon entry. If there is cause for concern, I am notified and proceed as I see fit. IE Not serving alcohol to said patron. In an extreme event, I would disallow entry.

This is an ALL AGES establishment.

I would like to note that we have been operating in this format since APRIL 2013 with no complaints to police, from the neighborhood, or incidents from our establishment. It is noted that during the ALRC meeting from March 2014 in separate context, that spokespersons from the neighborhood had no issue with the business that Crescendo has been running for the last year.
