Greetings Alder Harrington-McKinney,

Thank you for reaching out and sharing the resident concern with us! I want to provide an update on this.

We have added Piping Roack Rd near Sunridge Park to our Safe Streets Madison program candidate list for evaluation of traffic calming, including potential speed humps or other appropriate safety measures. As we have received a large number of similar requests citywide (nearly 650 of them right now) and we have limited budget and staff resources, we have to work with the Transportation Commission to prioritize them based on safety, impact, equity, and cost considerations. We have funded about 210 projects since 2022 with this new program, but the demand still far exceeds our budget capacity. We will see whether we can prioritize the project with the upcoming funding cycles.
