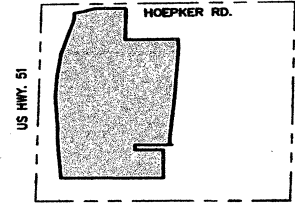

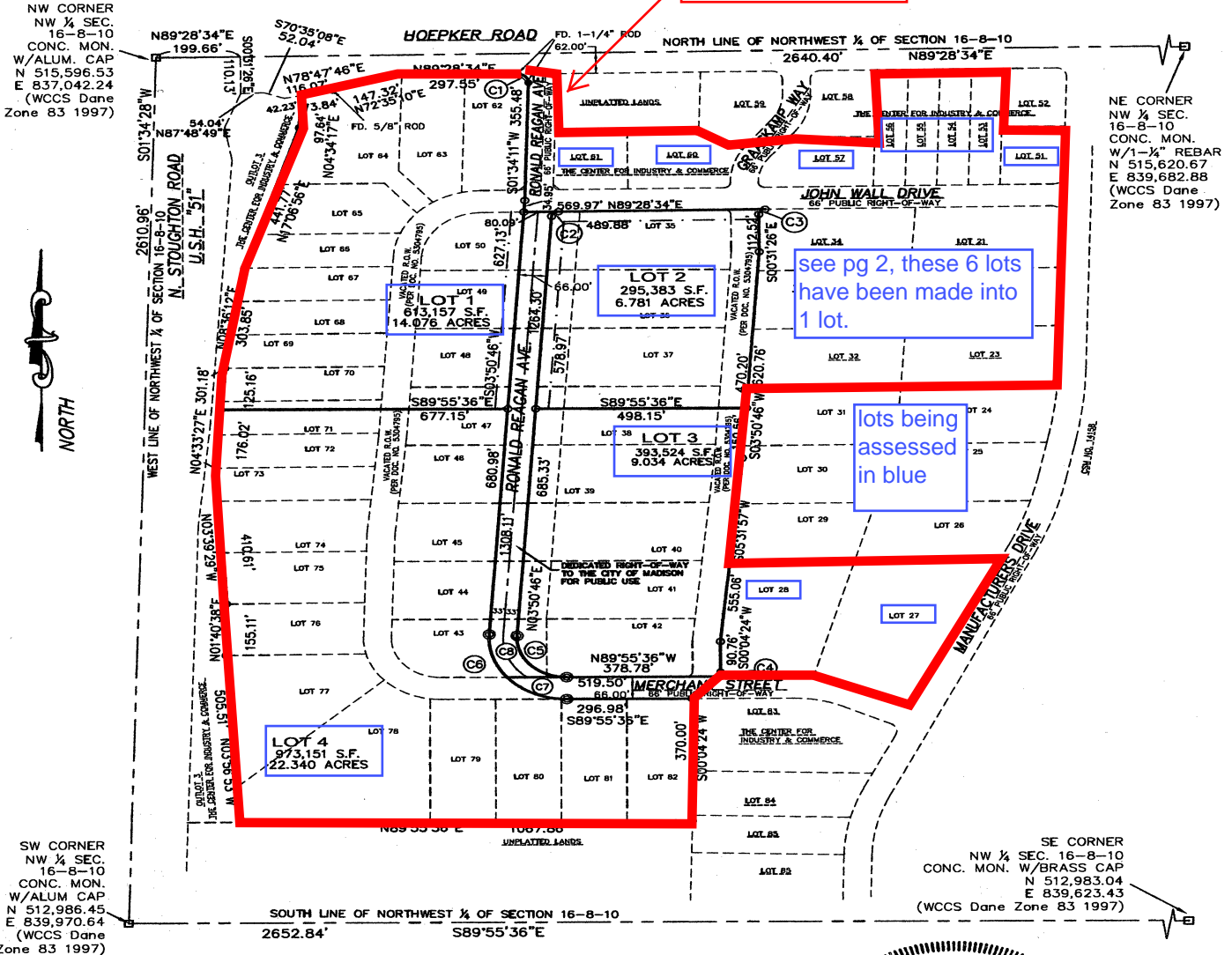

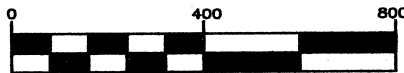


VICINITY MAP

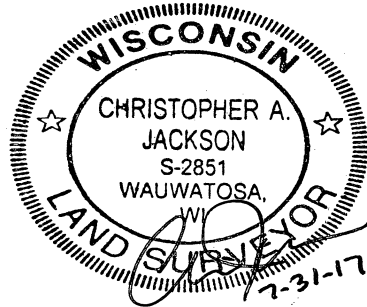

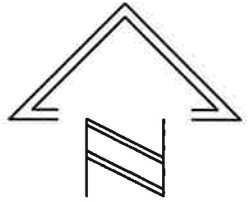

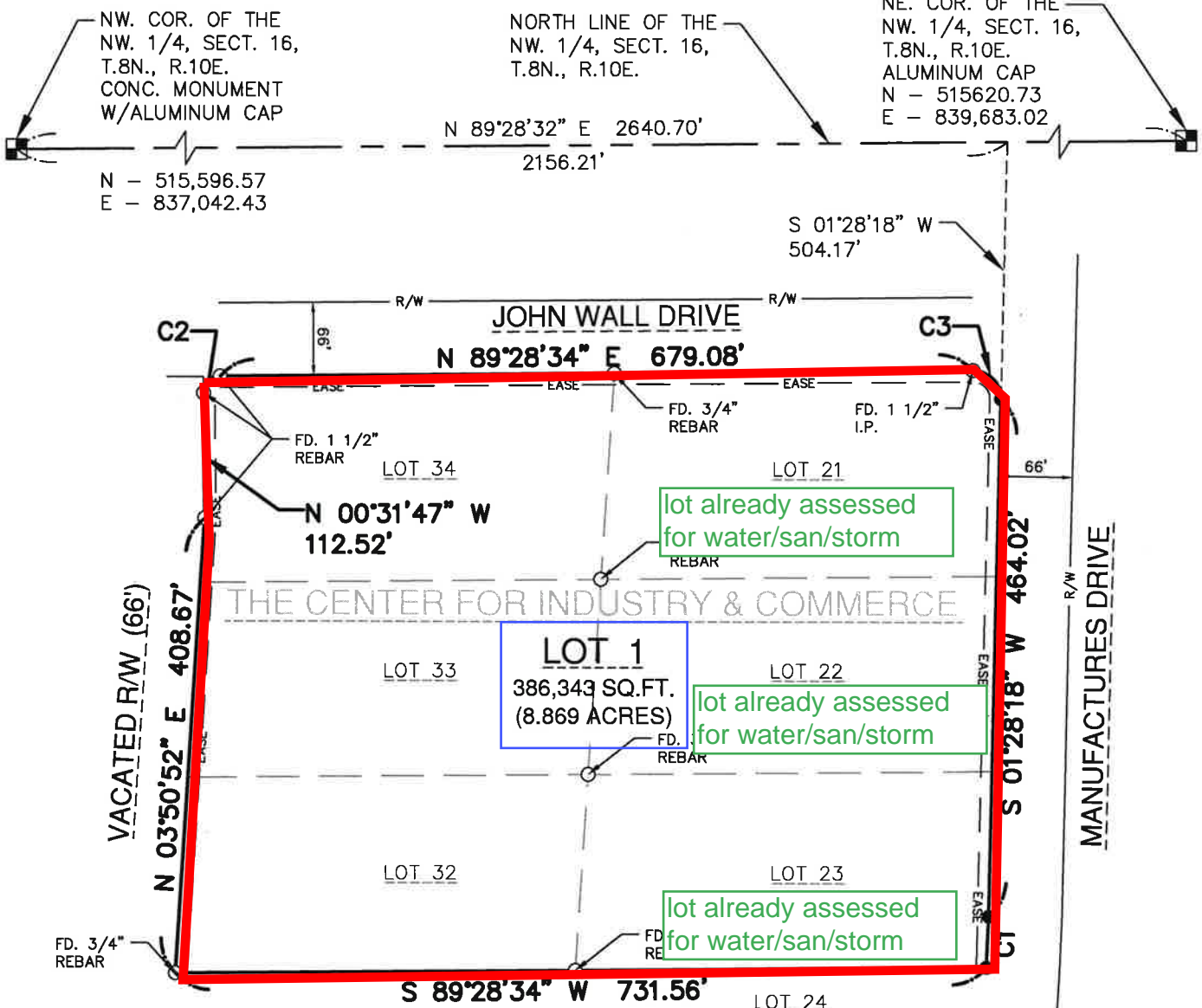
