Olson, seconded by Committee Member Sentmanat, to RECOMMEND TO COUNCIL TO REREFER - RECESSED PUBLIC HEARING to the ALCOHOL LICENSE REVIEW COMMITTEE Subcommittee to include the City Attorney designee, the Madison Police Department, the Alderperson, and two voting members of the Alcohol License Review Committee (Mr. Kamp and Ms. Wheaton), to bring back an agreement to the Alcohol License Review Committee. -- Appearances: Karen Martin (applicant), Wendy Helgemo representing the Ho-Chunk Nation, Darren Brinegar representing DeJope Bingo & Entertainment, Rosemary Lee, Dan Waisman, and Alderperson Compton. -- The motion passed by acclamation.

The following discussion and motion took place prior to the vote to refer this application.

Mr. Kamp said he would expect a smoking ban when Madison's ordinance becomes effective. Ms. Helgemo responded that the extent of the city's authority relates to liquor only, and that any other health, safety and welfare standards would have to come from federal law.

Captain Lengfeld said the Madison Police Department has not seen a clear plan on how underage drinking will be prevented. He said he would like clarification in writing on the ability of the Madison Police Department to enter the premises.

Dan Waisman spoke about his observations of liquor service at the Ho-Chunk Casino in Wisconsin Dells. He said he has observed neglect of responsibility there, as the only concern of the wait staff seemed to be getting as many drinks as possible into the poker room. He said he hoped for tight restrictions on the service of liquor in Madison.

Mr. Sentmanat asked the Ho-Chunk representatives whether they believed the city could put conditions on their liquor license. Ms. Helgemo responded that conditions would be a stretch, and that they would need to be strongly rooted in Chapter 125 of the State Statutes.

Attorney Zilavy said she has studied relevant case law, and that this is not the place to debate the legality of whether conditions would apply.

Mr. Hart asked the Ho-Chunk representatives whether they would be willing to accept a smoking ban. Ms. Helgemo said it would have to be a law that the Ho-Chunk Nation itself enacts.

Alderperson Olson expressed concerns about the outstanding details mentioned by Captain Lengfeld. She asked the applicants if they understand what the outstanding details are, and whether they were ready to address these details. Mr. Brinegar responded that they are looking at options for 18-21 year olds, and that they understand that the Police Department would like clearer lines to be drawn.

Mr. Kamp asked where the 18-21 year olds are now, and whether alcohol would be served in the food service area. Mr. Brinegar responded that 18-21 year olds currently are allowed throughout the entire facility, and that alcohol would not be available in the food service area because, with food being only three percent of revenue, they would not qualify for a restaurant liquor license.

Alderperson Olson asked if there was a clear path to achieving agreement on outlining the authority of the Madison Police Department to respond to calls. Ms. Helgemo said she thought the police would operate as they would elsewhere in the city. Captain Lengfeld said he was under the impression that the police would have to be invited into the establishment. Ms. Helgemo said she did not think that was the case.

Captain Lengfeld asked if the Ho-Chunk Nation could be brought to municipal court on liquor law violations. Ms. Helgemo said the city has the authority to enforce Chapter 125 of the State Statutes. Attorney Zilavy said the city's position is that it also has the authority to enforce Chapter 38 of the Madison General Ordinances, which also incorporates unruly patrons, smoking, delivery of alcohol, unlawful devices for vending alcohol, the ability to impose a Chief's Security Plan, the ability to get a search warrant, adult entertainment tavern licenses, and conformance to all health, sanitation, building and fire regulations of the city and state.

Alderperson Olson asked what kind of security staff would be on site. Mr. Brinegar said their current security staff is already better than any licensed establishment in Madison. He said there are 13 security guards, one shift supervisor, and one security director, with four or five on duty at any given time. He was not certain about the number of security guards on duty or where they would be posted.

Ms. Rearick asked if the applicants would continue to have a non-smoking room. Mr. Brinegar said they have not yet made that decision.

Ms. Rearick asked if DeJope has taken any measures to make arrangements with the Safe Ride designated driver program. Mr. Brinegar said they have not looked at Safe Ride, but that security has called taxis for intoxicated customers in the past. Ms. Helgemo said security is looking at the policies of other Ho-Chunk facilities with liquor licenses.

Alderperson Compton told the committee that she is never in favor of open-ended approvals, but that the Tribal Council cannot make a statement until the city has made a decision. She said she would like a decision to be made.

Mr. Shapiro said the Tavern League opposes this application because they are looking for a level playing field. He said Safe Ride is operated by the Tavern League, and that they would supply rides for DeJope if asked to do so. He expressed concerns about DeJope being licensed as a tavern with 18 year olds on premises. He said the ability of police to go on premises is unclear, and that he hoped the committee would see fit to deny the license if Ho-Chunk chooses not to comply with the Madison General Ordinances.

Downtown resident Rosemary Lee told the committee that she is concerned about the awfully large capacity of this entertainment venue, the unresolved questions about keeping underage patrons from drinking, and the undue burden placed on police with 1,200 people leaving the establishment at night.

Alderperson Olson said that, due to the size of the facility and its unusual relationship with the Madison Police Department, it would be best to have everything clearly outlined and agreed upon before making a recommendation to the Common Council.

Ms. Rearick said she would not feel comfortable granting a tavern license to an establishment with access to underage individuals.

Captain Lengfeld said he needs to see something in writing, signed off by the Ho-Chunk Nation, for enforcement purposes.

Attorney Zilavy suggested working out the details of this license application through another ALERT meeting. Ms. Rearick said she would be open to the issue of a smoking ban being decided through a Common Council amendment.

Alderperson Olson said she does not want to send something half-baked to Common Council. She said the Common Council would refer this back to the committee if the details were not already in order. A cleaner process would be to refer this to a subcommittee, she said.

Ms. Rearick said an ALERT meeting had already taken place, and was not adequate. Alderperson Compton said the applicants would like the license to be voted up or down.

Mr. Kamp said he would not support the approval of this license without addressing smoking and underage issues. He said he did not believe that DeJope would be happy limiting its licensed premise to such a small room in their facility.

Mr. Sentmanat said he did not feel comfortable voting to approve this license without a sense of what will be done regarding smoking. Ms. Wheaton said she believes the city does not have the power to dictate to a sovereign nation. Alderperson Olson said that, as with all other licenses before the committee, it would be best to deal with the details before recommending approval of a license.

Captain Lengfeld said the Madison Police Department still opposes this application until the details have been worked out. Mr. Shapiro said the applicants seem happy to take the liquor license, but none of the conditions that go with it. Mr. Billups said the committee needs to get some advice on how to deal with a sovereign nation.

A motion was made by Ms. Rearick, seconded by Ms. Wheaton, that the committee recommend granting with the following conditions: 1) Alcohol service to be limited to the current non-smoking room, accessible only to individuals ages 21 and older. 2) Licensed Premise to include the Bingo Hall for special events only, with access limited to individuals ages 21 and older. 3) The Ho-Chunk Tribal Council must have agreed to these conditions in writing before the Madison Common Council meets on May 3, 2005.

40. 00876

Amending Section 38.02 and creating Section 38.07(14) of the Madison General Ordinances to create a definition for keg and to regulate the sale of alcohol beverages sold in kegs in the City of Madison.

A motion was made by Ald. Verveer, seconded by Ald. Olson, to Refer to the ALCOHOL LICENSE REVIEW COMMITTEE -- Appearance: Alderperson Austin King -- The motion passed by acclamation.

#### 41. 00902

Creating Section 38.06(12) of the Madison General Ordinances to provide a definition for Centers for the Visual and Performing Arts and to establish licensing and operational requirements for such Centers.

A motion was made by Rearick, seconded by Ald. Verveer, to Return to Lead with the Recommendation to Approve as Substituted to the PUBLIC SAFETY REVIEW BOARD: In 38.06(12)(c)a strike "Has at lease one performance stage larger than 200 square feet" and replace with "Pays a fee to the perfomer when live entertainment is provided." In 38.06(12)(c)b reduce the capacity requirement from two hundred (200) patrons to one hundred (100) patrons. The motion passed by acclamation.

The following discussion took place before action was taken on this ordinance.

Ms. Rearick said she would prefer to have the definition of a Center for Visual and Performing Arts to be based on a fee paid to the performer. Attorney Zilavy said this would make the license available to every establishment in town, and would be contrary to the intent of the State Statute that this be a very limited exception.

Alderperson Verveer asked if the definition used by Milwaukee is very tight. Attorney Zilavy said that definition is very, very tight.

Alderperson Olson suggested that the initial definition apply to a limited number of establishments so the committee can make sure this is successful. Ms. Rearick said the committee would be very careful about approving the applications for this type of license. She said she is not aiming for a free-for-all.

Alderperson Austin King told the committee that, from a policy perspective, underage students could go to a Center for Visual and Performing Arts rather than house parties. He said this would undermine the fake identification industry in Madison.

Mr. Kamp said he would like to see this apply to bigger venues initially. Captain Lengfeld said this is speculation on everyone's part and that he would recommend starting out small, working out the bugs, and then expanding. He said this could take a lot of police resources.

Alderperson Verveer said this has been years in the making, so he would hate to delay it another month. Ms. Rearick said it really is not lucrative for establishments to bring in underage patrons because there is no economic incentive to market something other than alcohol.

Mr. Shapiro said the Tavern League endorses this ordinance. He said operators in the industry have everything to gain, and should be willing to bend over backwards to make this work because it is a special privilege.

Mr. Billups said this is long overdue. He said the university has been advocating for this since the beginning of the PACE project.

#### 42. 00930

Amending Sections 9.13(6)(j)2. and 9.13(6)(j)3, to eliminate the requirement that restaurant wait staff must carry and serve all food, beverage and alcohol beverages to patrons within a sidewalk cafe, and to allow patrons of all types of sidewalk cafes to carry out their own food, beverage and alcohol beverages from the restaurant to the sidewalk cafe.

A motion was made by Rearick, seconded by Ald. Olson, to Refer to the ALCOHOL LICENSE REVIEW COMMITTEE -- Appearance: Alderperson Austin King. Registered in Opposition: Dan Waisman. -- The motion passed by acclamation.

The following discussion took place regarding the above ordinance.

Captain Lengfeld said the Madison Police Department opposes this ordinance because of concerns about patrons leaving a premises and then talking to a friend on the sidewalk with an open intoxicant. An additional concern he mentioned is that more garbage would be blown off the tables if customers carry out their own food and staff does not maintain sidewalk cafes.

Mr. Shapiro said someone could go into a bar and purchase a pitcher of beer, then carry the pitcher out to underage individuals in the sidewalk cafe. He said patrons also could walk up the street with their beer.

Alderperson King told the committee that customers who carry food out to a sidewalk cafe do not get diverted, and that establishments are required to staff and monitor sidewalk cafes.

Ms. Rearick said she has been in a situation where it doesn't make sense to have an employee carry out your beverage, but that it does make sense to have a pitcher of beer monitored.

# 43. Meeting with Ho-Chunk Nation

Attorney Zilavy reported that the ALERT team had talked about the ability of the Madison Police Department to do walk-throughs at DeJope. She said there were issues with the presence of underage patrons on premise. The ALERT team had talked about security inside and outside the facility, but police concerns still remain. No agreement was reached on whether Madison's smoking ordinance would be followed.

Attorney Zilavy said the fact that the Ho-Chunk Nation is a sovereign nation does not end the issue there.
