D.1. [48112](#) 2016 Crash Report

City Traffic Engineer, Arthur Ross, went over the 2016 Crash Report. Ross stated the Crash report is a state form MV 4,000 that captures all motor vehicle crashes that are reportable to the state, and are reported by the state. In order for it to be reportable to the state, the crash must involve a motor vehicle, and either have an injury or apparent injury to a party, or involve damage to one persons property of \$1000 or more. Bicycle Pedestrian crashes are not included in this report, because they do not involve a motor vehicle. Foster asked if the commission could look at sharing the report cross departmentally to get input on how to make improvements. Rewey asked to see numbers in addition to percentages in the future.

Zellers asked if the comments would be entered into the new database. Ross said yes, along with the staff comments. Foster requested that staff put together an initial draft of suggested project prioritization for the commission to work off of. Zellers asked that if staff develops criteria for ranking projects, the commission should review the criteria. Foster suggested a good way to prioritize projects could be cost vs. benefit analysis.
