REFERRALS FROM THE COMMON COUNCIL

58222 Repealing Section 33.23 of the Madison General Ordinances to eliminate the

Solid Waste Advisory Committee.

Sponsors: Grant Foster and Keith Furman

A motion was made by Ald. Sheri Carter, seconded by Ald. Grant Foster, to RECOMMEND TO COUNCIL TO ADOPT - REPORT OF OFFICER.

This ordinance would eliminate the Solid Waste Advisory Committee. The Committee is currently tasked with limited duties, including making studies and recommendations related to solid waste and recycling issues, and reviewing City programs and operations on these issues. However, the Committee has frequently found itself with few referrals or actionable items for consideration. Matters that would otherwise be referred to this committee may instead be referred to other committees or even ad hoc committees depending on the issues involved.

Ald. Grant Foster was available to answer questions. He supported the creation of a "Friends of the Streets Division" organization. He noted that he was inspired by the TFOG's Report recommendations to reduce the number of committees and thought this was one committee that could be eliminated.

Ald. Marsha Rummel, chair, provided an update to the CCEC members. The work group will be requesting an extension to June 30, 2020 for a report back to Council (see attachment in legislative file). Specific policies, harrassment, code of conduct might benefit from a separate section in the policy guide (addition to charge / remedies and enforcement would go there too).

There was no objection to having the APM work group to work on a separate section that would go to into the policy guide or extending the deadline to June 30, 2020.

The City Attorney would draft the resolution to extend the deadline and clarify the scope of work to review adding a new section on APM procedures and enforcement to the Council's Policy Guide.

59118 Update: President's Work Group on Council Communication Tools & Processes (2/4/20) - Ald. Grant Foster, Chair

Ald. Grant Foster, chair, provided an update to CCEC members.

Current practice: PIO's send emails and then the press release would come through the city's press release system (sometimes a third version as well). The work group recommended a more streamlined process that would reduce the number of emails that alders receive on the same subject.

Work Group recommendation: Add all aldermanic email addresses to receive the City's News Releases. Then at the beginning of next month the PIO's can stop sending out emails to all alders that contain the same information as the news releases.

Eric Olson will also email alders instructions on how to subscribe to the city's Email lists and AlertMadison. These are communication tools staff use to send information, alerts, notifications, and updates (https://my.cityofmadison.com/index.cfm).

Ald. Foster also noted that the work group may request an extension to their report timeline as well.
