#### 5 17719 HOUSING OPERATIONS MONTHLY REPORT

Olvera and Conrad reviewed the Housing Director's monthly narrative report (attached to minutes). A motion was made by Fike, seconded by Levitan, to Accept. The motion passed by voice vote.

#### 6 21255 ECONOMIC DEVELOPMENT STATUS REPORT

Brown reviewed the Economic Development Status Report:

- Two accepted offers and one contract at Lake Point Condominiums.
- The Reservoir, Duplex and Revival Ridge are fully occupied.
- Occupancy at Monona Shores remained at 91.3%. There were 12
  rejected applications during the month of June, bringing the total for
  the year to 30. Members requested that a summary report be
  provided at the August 11 meeting on the reasons for the rejections.

A motion was made by Thompson-Frater, seconded Bruer, to Accept. The motion passed by voice vote.

Amending the Façade Improvement Grant Program Objectives and Criteria to specify that governmental entities and public and quasi-public authorities are ineligible for Façade Improvement Grants

Brown introduced the amendment, noting that staff has no problem with the proposed amendment as it is in keeping with the intent of the program. Since the program was enacted in 2000, 100% of the grants have been issued to small businesses. Bruer, one of the sponsors of the resolution, stated that the Facade Improvement Grant Program is a popular program and he wanted to see it stay on a positive course. Brown stated that a number of Alders had expressed concerns regarding the CDA's recent application for Facade Improvement Grant funds to assist The Village on Park south facade. Levitan noted that by excluding quasi-public authorities,
