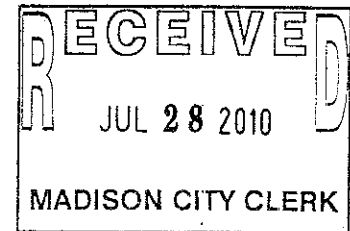


Greetings:
