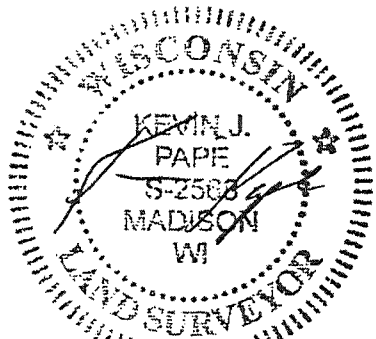
LOT 8 AND PART OF LOT 7, BLOCK 7, MENDOTA BEACH SUBDIVISION, LOCATED IN  
GOVERNMENT LOT 2, SECTION 18, T7N, R9E, CITY OF MADISON, DANE COUNTY, WISCONSIN



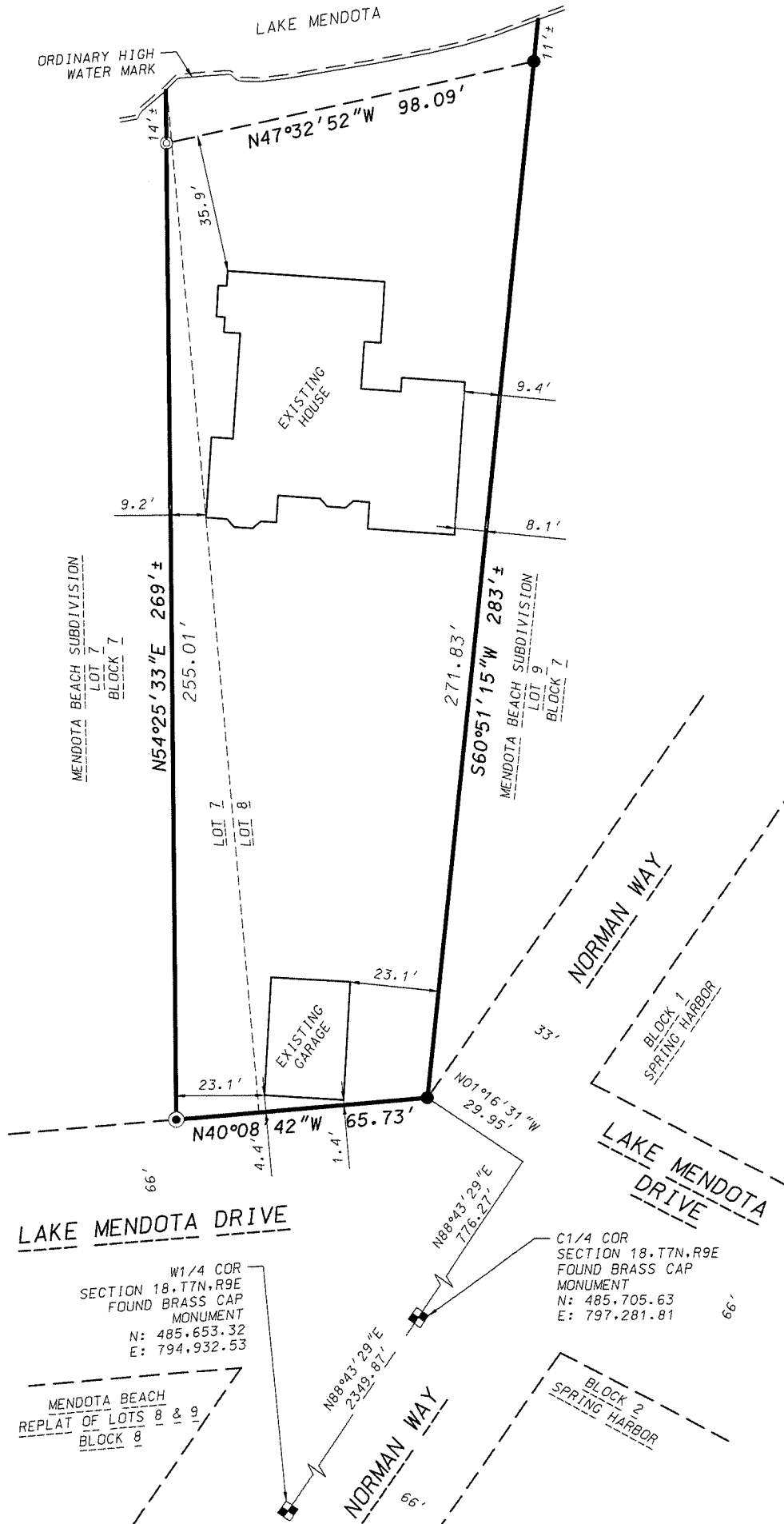

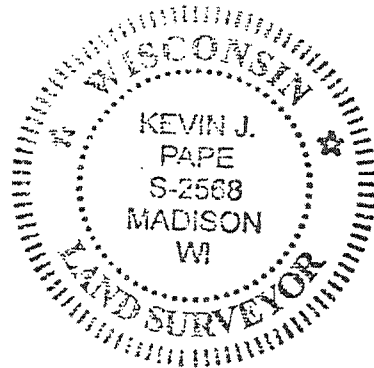
## SURVEYOR'S CERTIFICATE

I, Kevin J. Pape, Professional Land Surveyor, S-2568, do hereby certify that this survey is in full compliance with Chapter 236.34 of the Wisconsin Statutes and the Subdivision Regulations of the City of Fitchburg, Dane County, Wisconsin and under the direction of the Owners listed below, I have surveyed, divided and mapped the land described herein and that said map is a correct representation of the exterior boundaries of the land surveyed and the division thereof. Said land is described as follows:

Being Lot 8 and part of Lot 7, Block 7, Mendota Beach Subdivision, located in Government Lot 2 of Section 18, T7N, R9E, City of Madison, Dane County, Wisconsin, described as follows: Commencing at the west quarter corner of said Section 18; thence N88°43'29"E, 2349.87 feet along the south line of the SW1/4 of NW1/4 of said Section 18 and the south line of Government Lot 2 to the C1/4 corner; thence continuing N88°43'29"E, 776.26 feet; thence N01°16'31"W, 29.95 feet to the southwest corner of said Lot 8 and point of beginning; thence N40°08'42"W, 65.73 feet along the northeasterly right-of-way line of Lake Mendota Drive; thence N54°25'33"E, 255.01 feet to a meander corner that is S54°25'33"W, 13.7'+/- for the water's edge of Lake Mendota; thence along a meander line S47°32'52"E, 98.09 feet to a meander corner that is S60°51'15"W, 11.0'+/- from the water's edge of Lake Mendota; thence S60°51'15"W, 271.83 feet along the northwesterly line of Lot 9, Block 7, said Mendota Beach Subdivision to the point of beginning. Said parcel contains 22,000+/- square feet (0.50+/- acres) to the edge of water.

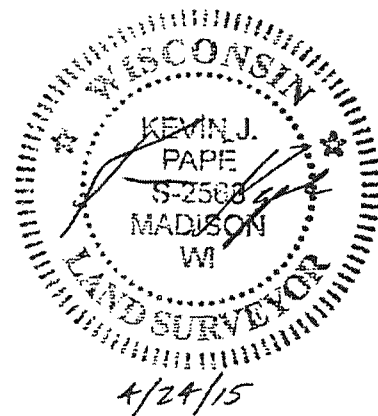
