

#### Site Dimensions and Area

The subject consists of two parcels. Parcel 1 is 198.4 feet wide by 150.13 feet deep, is 29,700 square feet, and has 198 feet of frontage on East Washington Avenue to the southeast and the same frontage on Curtis Court to the northwest. Parcel 2 is 66.14 feet wide by 150.13 feet deep, is 9,900 square feet, and has 66 feet of frontage on East Washington Avenue to the southeast and the same frontage on Curtis Court to the northwest.
