- Investigate the potential for implementing a system to capture rooftop runoff for washing trucks on site.

- Option 2 (39.7 square feet for "aloft" sign and 3.7 square feet for "W Hotels" sign) for the east elevation of "aloft" is approved.
- Option 2 (39.6 square feet and 2'-9 ½" above the canopy) for Fratellos is approved.
- The signage on the upper portions of the west facade must come back to the Commission with a proposal that depicts the "aloft" sign at 50 square feet (as in Option 4), the "W Hotels" sign at approximately 8 ½ square feet (as in Option 3), and raising the "aloft" sign above the main building parapet (as in Option 6).
