1. CALL TO ORDER

5. UPDATE ON CHANGES WITHIN THE OFFICE OF COMMUNITY SERVICES

Enis Ragland, previously of the Mayor's office, will be the Interim Supervisor of OCS through the end of 2008. OCS will hire a new Program Assistant, probably before the end of November. A decision will be made then on who, if any of the administrative staff, will take minutes at SCAC, ECCEB and CSC meetings.

6. SENIOR BEAT UPDATE - HELEN AARLI

Helen hosts Senior Beat on Channel 12. Helen asked for feedback on how to make seniors aware of Senior Beat, and for program ideas. Helen is also interested in how people view the current topics, and what they feel should be covered. Senior Beat may be taped and the tapes made available to whomever wants to see them, including assisted living facilities. Members suggested health issues (e.g. shingles vaccine), and managed care changes as possible topics.

7. REVIEW OF THE PRESENTATION ON HEALTH CARE ISSUES FOR SENIORS BY JUDY HOWARD, AND DEVELOPMENT OF ACTION STEPS

At her July SCAC presentation, Judy Howard raised three health issues: social capital, health literacy and a community assessment. Ald. Schumacher suggested that alcoholism and addictions are issues that also need addressing. SCAC members

discussed their role in health efforts and raised the following issues:

What is the SCAC role - should SCAC coordinate efforts that already exist, e.g. on social capital?

Should SCAC be a gatherer and/or disburser of information?

Should SCAC consider the gravity of health problems and identify what is the greatest need?

SCAC is not a working Committee and has no budget; to become a coordinator of current efforts is a big change.

Is the SCAC goal information gathering, or should it seek funding to implement changes? Most SCAC activities (dehydration brochure) and the programs we fund (case management) are either social capital or health literacy efforts.

Does SCAC have the energy and interest to change how it does business?

It was agreed that the SCAC would invite Judy back to help focus the SCAC health efforts. Judy could identify where SCAC could partner with the Health Department efforts.

8. REAPPOINTMENT OF MICHAEL ELY TO THE COMMUNITY SERVICES COMMISSION

A motion was made by Carstensen, seconded by Storkson, to recommend that Michael Ely be re-appointed as the SCAC representative on the Community Services Commission. The motion passed by the following vote:
