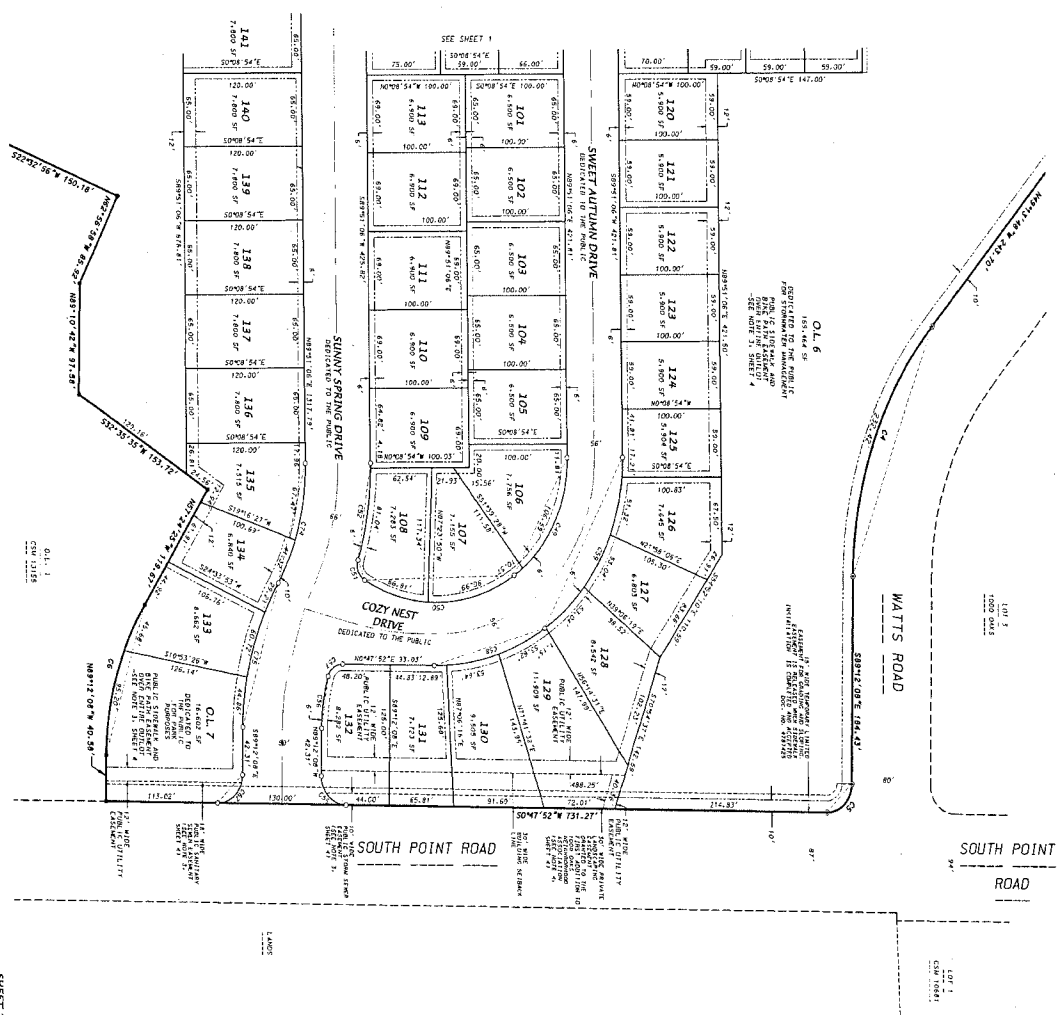
PART OF LOT 1, CERTIFIED SURVEY MAP NO. 13155

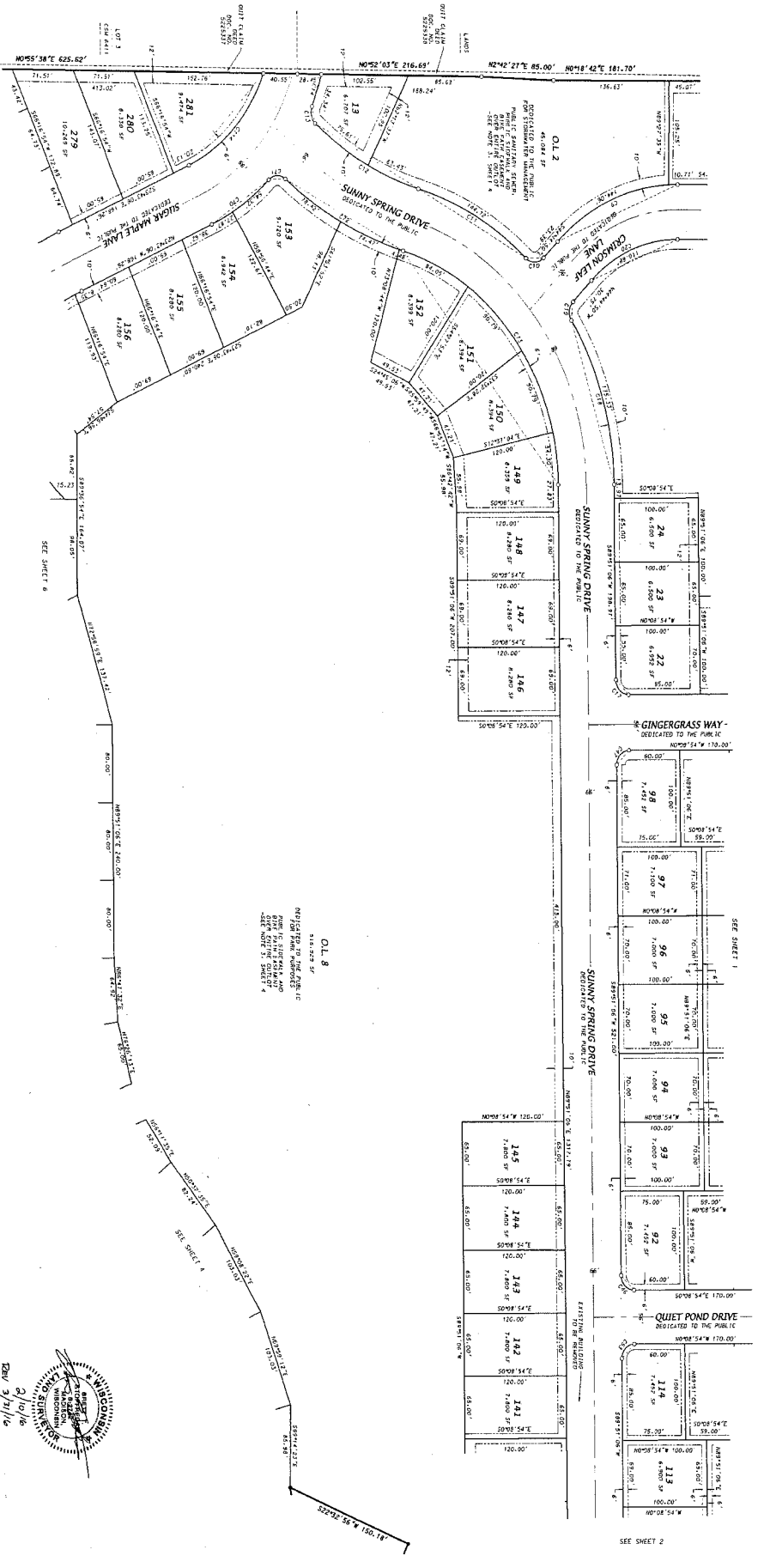

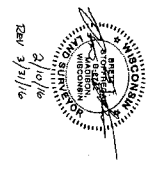

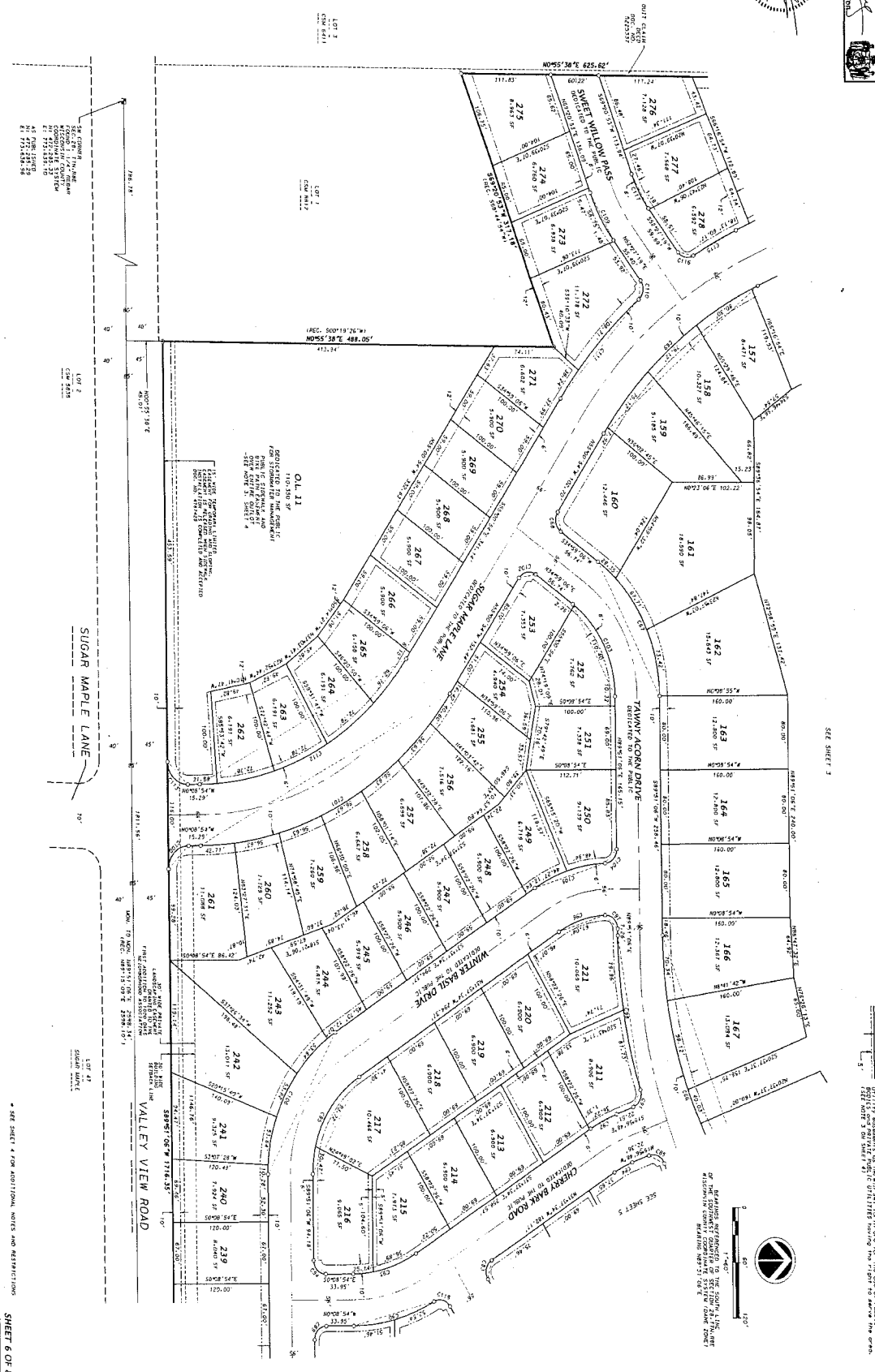
