SUPERINTENDENT'S REPORT – OCTOBER ACTIVITIES, 2011 EAST PARKS – CRAIG KLINKE

We had unseasonably warm weather for October. We had good conditions to continue working on some of the special projects we wanted to complete before the beginning of winter.

We are still aerating and renovating the soccer fields and softball diamonds. We are flail mowing native managed meadows. We are using a combination of blowers and mulching to remove the large amount of leaf debris in the areas that are heavy with trees. We are removing tables, benches, and barrels from parks. We are installing signs on shelters to comply with the city's concealed carry policy. Lastly, we are converting our equipment for winter use.

Some of the work that we completed in October included:

- We removed a lot of invasive shrubs at Olbrich Park. We opened up the area along Atwood Ave. to create a more welcome environment and to increase visibility.
- We performed shoreline work along the Tenney Park Lagoon. We removed invasive species, grubbed stumps, and removed other vegetation to create better conditions to remove snow during ice season.
- We installed sod at Breese Stevens.

We are looking forward to the completion of the work at Tenney Park. We are anxious to get into the new shelter to get it ready for the winter, including raising the water level back up to prepare for the ice sports season. We are also waiting for the work on the outlet structure to be completed.

WEST PARKS - KRISTIN MATHEWS, INTERIM PARKS SUPERVISOR

The October weather continued to be beautiful, and the conditions contributed greatly to our fall clean-up efforts. We were able to mulch more leaves than we have in years due to the weather and the fact that we still had several seasonal employees to help us out. We also acquired a new blower to help with the leaf clean-up.

The renovations we are working on at the ball diamonds at Elver are going well. Fall football came to an end a few weeks ago. In addition to the renovations at the ball diamonds, we are also aerating all of our athletic fields.

The welder began going over all of the plows to make sure that they're in good working order for the winter season. The mower mechanics began changing over the mowers to blowers for the snow season, as well.

The hayrides are coming to an end in most of the parks. They will continue well into November at the *Holiday in Lights* show at Olin Park. Some of our seasonal staff have really stepped up to help with driving the hay wagons. That was *much* appreciated!

Lastly, all of the shelter sides are up at our winter shelters. Soon we'll be in full winter mode.

MALL CONCOURSE - TOM SKAIFE, SUPERVISOR; LAURA BAUER, LEADSWORKER

During the month of October, Mall/Concourse activities were centered on the change of seasons and preparing for *Freakfest*. We are collecting leaves and hauling them to composting sites. This continues until it snows, because many the trees on the Capitol lawn have a late leaf drop, and a good number of their leaves blow onto our side of the street. The portable planters on State St. and the other side streets have been emptied and are awaiting their winter arrangements. The arrangements are due to be installed in the middle of November. Our perennial plantings are being cut back, as well.

Freakfest went well this year. We did not note any major damage to the public amenities as we have in the past. The weather cooperated with the cleanup; it was neither rainy nor very windy. Ending the event before bar time always presents difficulties, as the bar-goers hang around on the sidewalk, but we expect this and are able to adapt.

Coinciding with *Freakfest*, the Bicycle Recovery section of the Police Property Room made a sweep of State Street, removing bicycles that appeared to be abandoned. We are working with the Property Room on a plan to do be able to do this more frequently. We've had a couple of difficulties in this attempt. One was, there used to be a secure storage space issue, but we've been able to resolve this problem. A different challenge is that the number of property room staff available to maintain the proper chain of custody for the bicycles is limited. We're looking forward to addressing the bicycle issue. Removing abandoned bicycles is advantageous for everyone in several ways; rack space is then more

likely to be available for shoppers, the bikes will not be sidewalk impediments, and the area will look more attractive.

Occupy Madison spent a few weeks in October camping at the 30 on the Square performance space, but it seems that they've now found a new home in the very large lot of a vacant car dealership on East Washington Avenue, several blocks east of the Capitol. This should work out better for all involved, as the 30 on the Square area is small, does not have sanitary facilities, and was never intended for 24-hour occupation.

Going into November, we'll be readying our snow removal equipment and hauling a load of salt to our shop. We do not hope for an early winter, but we'll be ready for it when it comes.

CONSERVATION – RUSS HEFTY

We performed ski trail preparations at Elver Park and South Cherokee, mowing along trail edges and trimming back overhanging limbs. A contractor completed the construction of a trail segment at Door Creek near Bluff Point Dr. Extensive grading was required to shape in a trail along this wooded slope in the park. This project completes the first trail loop in Door Creek. In the future, additional loops are planned to the east of Door Creek on City of Madison and Dane County parkland.

We completed construction of a hiking trail at Hiestand Park. The trail originates on Wittwer Rd. (the west side of park) and winds through the disk golf course to join the trail system in the conservation area on the North Slope of the park.

The major activity for the month was performing buckthorn and honeysuckle control at Cherokee Marsh and Owen Parks. At Cherokee, the crew swept through the area that had been mowed by Forestry to cut and treat the exotic shrubs that were not accessible for mowing. We also cleared by hand an area that may be an effigy mound in the shape of a water spirit or serpent. At Owen Park we also targeted Norway Maples along the entrance drive into the park.

Volunteers from *Friends of Olin Turville* (FOOT) collected seed at Turville Point Conservation Park, and then spread it in oak woodland restoration areas we've been clearing. Volunteers from the *Friends of Cherokee Marsh* collected seeds from sedge meadow wildflowers and spread them in the east marsh where we filled the ditches this past summer.

FORESTRY - MARLA EDDY

The first half of the month was spent on tree removals and requests for pruning. The latter half was spent on fall planting. We planted a total of 723 street trees across the City of Madison.

GOLF – RAY SHANE

At the end of August, the revenues from our golf courses were lagging behind 2010 levels by approximately \$61,000. At the end of October, that amount had remained constant. A major reason behind this is this year's cool and wet spring.

The end of the golf season is fast approaching with course closings coming in the next few weeks. Staff have been busy with winterization projects, such as blowing out the irrigation systems, servicing furnaces and boilers, fall turfgrass maintenance, and leaf clean-up.

Equipment is being prepared for winter over-hauls by performing assessments, writing repair requests, and steam-cleaning the equipment prior to storing. Some products that we will be using in 2012 have already been ordered, maximizing early season discounts and rebates.

Staff is in the process of reviewing operations, programs, and policies that are currently in place to identify specific areas for improvement.

PLANNING AND DEVELOPMENT – KAY RUTLEDGE

Breese Stevens Entrance Improvements

Construction is complete for the Breese Stevens Entrance Improvements.

Rennebohm, Wingra and Door Creek Path Paving

Construction is complete for the paving of paths at Rennebohm, Wingra, and Door Creek Parks. The new backstop at Rennebohm Park that was included in this project will be installed the week of October 31.

Door Creek Athletic Fields

Construction is complete for the two athletic fields at Door Creek Park. This project was completed by Parks Construction.

Door Creek Ski Trail

Construction is complete for the Door Creek Ski Trail.

Wirth Court Park

The installation of the playground and other amenities at Wirth Court Park is complete.

Managed Meadows

Native grasses, sedges, and wildflowers have been installed at High Point Park, Vilas Park, Cherokee Park, and Kennedy Park.

Warner Park Parking Lot

The Parks Division will be reconstructing the Warner Park parking lot in three phases over the next three years. In Phase 1, (fall 2010), we replaced the storm sewer and built two retention ponds that will hold all of the parking lot run off prior to it going into the channel and lagoons. Phase 2 includes Bay 3 of the parking lot and the complete roadway through the parking lot. Bay 3 of Phase 2 will be completed in the spring and the remainder of Phase 2 will be done following the 2011 Mallards season. The fall part of Phase 2 is 75% complete. The curb and gutter is in, the asphalt binder course is in, and all terraces and islands are topsoiled. The surface course will be laid the week of October 31- November 4. A dormant seeding will start the following week. Tree planting and landscaping will follow under separate contract.

Olbrich Park Softball Light Replacement

The project is 35% complete. The old lights came down the end of October. All trenching and conduit installation is expected to be done by the beginning of November. The wiring and footing installation is to follow.

Thut Park

Engineering has completed lining the sewer pipe. The construction to improve runoff collection will begin the week of October 31.

Tenney Park Pavilion

The project continues to move forward with completion expected to be in mid-November. The exterior of the building is finishing up, and all site grading, asphalt, and seeding have been completed. The interior finishes and plumbing are underway, along with electrical work and heating and ventilation system installation. Interior painting is completed, and the cabinetry has been installed in the concession room.

Tenney Park Maintenance Bridge

In mid October, we hired *Bloom Companies* through our RFP (Request for Proposal) process to be the design consultant for this project. We are meeting with the consultant on October 28, 2011 to begin the design process.

Playgrounds, Paths and Basketball

The Klief and Quarry Cove playgrounds are complete, with the exception of final punch list items. Meadow Ridge Park basketball court is wrapped up, with the exception of striping that may need to be delayed for warmer weather in spring 2012. Monona Park playground is in construction. Baxter path was paved by the Dane County Highway Department, and shoulder restoration and signage is to be completed in the near future, with a grand opening planned for spring 2012. The paths at Secret Places Park, Goodman Park, James Madison Park, and Odana Hills Park all have base and are ready for asphalt.

Park Landscaping

Fall landscaping will be installed within the next few weeks. This will include screening plantings and trees at Rennebohm Park, and landscaping the new parking islands as part of the Warner Park Parking Lot project.

Olive Jones Park

We are working with the Facilities Management staff in hiring the design consultant to prepare the plans and specifications for the repairs and replacement of the retaining wall. This will be incorporated into the contract that will also include the pavement and fence replacement around the perimeter. We are working with the neighborhood representatives to complete final paver inscriptions and modifications.

Marshall/Spring Harbor Park Dredging

The Marshall Park dredging is scheduled to start October 31, and the scheduled start for Spring Harbor is November 14th. The completion of both projects is expected to be December 16.

Park and Open Space Plan

Sections of the draft report were presented for review and discussion with the Long Range Planning Sub Committee on October 17. A draft of the plan will be distributed in November for review by staff and agency as well. Meetings have been scheduled with Long Range Planning for November and December to continue the review and comment process as sections of the report are completed and revisions are made.

Other Projects

- Continuing to work with Parks and Engineering staff to site facilities and solicit bids for amenities for the Cannonball Trail.
- Continuing to work with the Glen Oak Hills volunteers and the alder to provide trees for their ongoing planting days with funds raised by the Neighborhood Association.
- Parks staff met with the neighborhood to discuss three options for improvements to Hudson Park on October 25, 2011. The neighborhood chose a final option and will form a design committee to work with staff on the final design.
- Working with Planning to develop a park map and environmental education materials for Hiestand Park. Park Operations has completed the construction of the trail through the Conservation area.
- Working with Planning on the Arbor Hills/Leopold Neighborhood Plan.
- New park signs, (either new parks or replacements of damaged park signs) have been installed at Droster, Lucy Lincoln Heistand, Marshall, Paunack, Patriot, North Star, Cardinal Glenn, Door Creek, Brittingham Beach, Quarry Cove and Linden Grove Parks, and at the Monona Golf Course.

WARNER PARK COMMUNITY RECREATION CENTER – BRAD WEISINGER General information.

Snow guards were installed in October. Areas included the lobby and the exercise room. The 12th annual *HolidayFest Arts and Crafts Show* has been scheduled for December 3 from 9:00a.m. to 3:00p.m.

Food for Free Fitness

From October 10-31, WPCRC helped our Northside Neighbors. When people brought in nonperishable items (i.e. canned goods, sealed boxed foods, sugar, flour, and hygiene products) they received access to the exercise room or open gym.
