REPORT TO THE MONONA TERRACE BOARD OF DIRECTORS

February 20, 2025

A. <u>Administration:</u>

- The new Momentus exhibitor service center module a.k.a. "webstore," had a very smooth roll out. The first event to use it was January's Madison Home Expo. The procedures for onsite use of the webstore were tried and tested. Staff is working on refining the procedures but is very pleased with the system overall.
- Staff is training on another module with Momentus. It used to be called Sale's Quotes, but in the new system it is called Service Order Forecasts and operates differently. AV has been the primary user of Sales Quotes; however, Sales is interested in using this system to provide quality quotes to customers within the database so that when a prospective client becomes a definite client the quotes can be converted to actual service orders.

B. <u>Operations:</u>

- The building was closed for maintenance from January 6-8. Maintenance projects included valve replacements in the Grand Terrace, repair and patching of the level 4 east dome, carpet replacement in all passenger elevators and repair of the air conditioner in the Lake Vista Café.
- Work on the east side structured cable replacement project began in January and should be completed by the beginning of February.
- The HVAC software called Metasys has been updated. Training was arranged through Johnson Controls for the maintenance team.
- The scissors lifts and pallet jacks were inspected and serviced. The Skyjack 4626, the largest of the scissor's lifts, is 28 years old and must be retired. Staff is currently gathering quotes for a new scissors lift with the same maximum height, but narrower to make it easier to maneuver throughout the building.
- Staff is meeting with Fleet services to discuss replacement for the outdoor sweeper. It has been with the building since 1997 and is not repairable.

C. <u>Community Relations:</u>

• Monona Terrace introduced a new program this January, the **Sound and Sense Immersion Workshop**, led by instructor Joan Herzing. This in-person event took place on Sunday, January 12, from 1-3 pm and offered participants a unique, multi-sensory experience focused on the connection between sound, movement, and mindfulness. The workshop had a strong turnout with 101 attendees.

- The **Yoga Core** program remains a community favorite, offering hybrid sessions led by Jo Temte and Devonna Peters every Tuesday and Friday at noon, running January 14 through May 23. Sponsored by Friends of Monona Terrace, the program saw a total of 573 participants in January, averaging 115 per session—505 attending virtually and 68 were in person.
- The *Lakeside Dance Lab* series continued to draw strong participation with its *BollyBeat* session on January 23, led by instructor Manisha Bharagava. This high-energy dance class introduced participants to Bollywood-inspired movements in a fun and inclusive environment. Held from 6 to 7 pm, the session attracted an impressive 241 attendees, reflecting the community's enthusiasm for diverse and culturally engaging fitness opportunities.
- In January, we hosted the Unitarian Meeting House docents for a hands-on session exploring Froebel blocks and facilitated a discussion between local teachers and the AIAW's Architects in Schools Committee to enhance architectural education in classrooms.

D. <u>Gift Shop:</u>

- The Gift Shop conducted its Annual Inventory and is now using that data to guide 2025 purchases and meet with vendors.
- The Gift Shop has finally been able to get a few favorites back in stock. All these products have been experiencing supply chain issues since the pandemic, the Mission Lamp, Midway Gardens Chess Set and the Midway Gardens Sprite Statue Collection (pictures below):







E. Sales and Marketing:

- The January booking pace report is attached.

 - Simple Life Hospitality is a new client that has booked their upcoming 2025 Simple Life Hospitality Planning Meeting.
 - Operation Fresh Start booked their 5th Annual Gala with Monona Terrace (1st year w/MT).
- Repeat Events:
 - Dane County Farmers Market rebooked their Holiday Farmer's Market for winter 2025. This event has been here every year since 2010 except for 2020 (COVID).
 - o TREK Retail and Dealer Convention will be here in November. This is a

repeat event from 2024, and TREK staff is thinking this may be growing back into the large "TREK World" events we hosted pre-COVID.

- Wisconsin Realtors Association booked their 2026 WI Realtor and Government Day with MT. They have been with us since 1998. In 2018 they went to a new venue and came back to us in 2023.

H. <u>Catering</u>

- 2024 was a strong year and showed continued growth over the past few years. Monona Catering's revenue for the year was \$7,014,297 (pre-audit) which was an increase of 2.51% higher than the 2023 revenue of \$6,842,495.
- THE 2024 SERVICES WERE:
- Hospitality (coffee breaks) 296,557 guests
- Meals (breakfast, lunch, dinner) 85,727
- Receptions 66,581 guests
- Total Services (including all misc.) 562,784 guests
- Monona Catering donated approximately 6771 pounds (3.4 tons) to local shelters.
- Approximately 41,420.00 pounds (20.7 tons) of pre-consumer waste was diverted from the local landfills through the composting program. From a greenhouse gas equivalency standpoint, these composting efforts are equivalent to 273 urban tree seedlings grown for 10 years.
- LAKE VISTA CAFÉ
 - The Lake Vista Café season began on May 21st and ran through September 22. The season started off with quite a few rainy days, which resulted in slower sales. The Monona Catering Culinary team introduced new items such as the Chojin Salad, and the Korean BBQ Taco.
 - The total revenue for the café was \$140,552 which was 6.2% lower than

the 2023 season.

- 2024 MARKETING ACTIVITIES
 - Monona Catering participated in several marketing activities throughout the year, which include Client and Wedding Menu tastings, the Winter Prom event in January, and the summer client appreciation event, in August.
- 2025 PROJECTIONS
 - Monona Catering projections are steady and comparable with 2024 with revenues at approximately \$6,975,000. The first quarter starts off with some nice events such the return of the Findorff Employee Recognition party in February and the American Family Children's Hospital Friends Gala in March. With the conference and conventions this year, we are looking forward to continued growth.
