- Consider approving the Minutes of the Board of Public Works Meeting of July 2, 2008 and the Public Hearing of the same date.
- 2. 11257 Consider a Report of the City Engineer regarding the results of a review of water resources impacts and the necessity of permits for public works construction projects on this agenda and addendum to the agenda.

CONSIDER THE FOLLOWING PUBLIC HEARING ITEM:

3. <u>11259</u> AT&T will be extending its fiber optic network within the City of Madison during the new few months, July through October 2008. This work is being done in order to enhance existing facilities in the Madison Area.

RESOLUTIONS APPROVING THE CONSTRUCTION OF PUBLIC WORKS PROJECTS

14. Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Olbrich Park Shoreline Repair, Contract No. 5923. (6th & 15th ADs)

Estimated cost of this project is \$360,000. This project consists of stabilization of the shoreline of Olbrich Park using vegetated boulder revetment along most of the shoreline, and flat stone steps in a few access points.

15. 11270 Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Glenway/Forest Hills Greenway Improvement, Contract No. 6177. (10th AD)

Estimated cost of this project is \$260,000. This project consists of repair of the eroded greenway north of the Southwest Bike Path and south of Glenway Golf Course and Forest Hills Cemetery. A riprap channnel with one piped section is proposed. A gabion trap and two catch basins are also proposed to capture sediment. An access road is proposed down from the bike path to the gabion, and also down from the bike path to the catch basins.

16. 11271 Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Wingra Creek Parkway Improvements - Phase 2, Contract No. 6179. (13th AD)

Estimated cost of this project is \$780,000. This project consists of streambank stabilization along Wingra Creek between Fish Hatchery Road and Park Street. This is the second phase of implementation of the Wingra Creek Master Plan. The project also includes replacement of storm sewer outfalls and installation of stormwater treatment devices.

17. 11272 Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Fire Sprinkler Installation at Fire Station No. 3 and No. 9, Contract No. 6247. (6th & 11th ADs)

Estimated cost of this project is \$101,618. This project calls for the installation of fire sprinkler systems at Fire Station Nos. 3 and 9.
