## Report to Council of Non-Bid Public Works Construction Project Completed Using City Staff

# **Background**

In order to close a gap between areas of the water distribution system on the east side of Madison, Madison Water Utility crews installed approximately 60 feet of new water main at the intersection of Worthington Avenue and Rosemary Avenue. This project allowed for the hydraulic connection of two dead-end water mains in the former Waunona Sanitary District No. 2 that Madison Water recently acquired. This connection improves water quality, increases redundancy and lessens the number of customer service outages during maintenance or emergency repairs.

The water main connection was completed in July 2018, along with a temporary street patch. The project was completed in September 2018 with installation of the permanent asphalt trench patch.

This report is intended to inform the Mayor and Common Council and to satisfy the requirements of Wisconsin Statute 62.15(14).

#### Scope of Work

The project required five MWU crew members working for approximately four days to perform the following scope of work:

- Mobilization of equipment and materials
- Set up and maintenance of traffic controls
- Excavation of trench for placement of new water main
- Installation 60 feet of new 6-inch water main, including valves and fittings
- Removal and hauling of material off-site
- Transportation and backfill of imported select fill
- Installation of a temporary road patch
- Flushing and testing of new main prior to putting in service
- Installation of permanent asphalt trench patch to complete street restoration

### **Recycling and Waste Disposal**

- 125 CY of original soil was removed and landfilled due to its high clay content and lack of suitability for street construction
