### Hello Jerry,

I included this request in an email thread to Yang Tao last week. This intersection came up a few times this spring when I knocked doors in the south areas of Heritage Heights and Rolling Meadows. The concerns were mostly from a driver's point of view where drivers struggle to find gaps in traffic during rush hour. Residents noted that traffic there has noticeably grown in the last few years as Grandview Commons develops, and that they've had to pull into the median (which is narrow right there) to wait for separate gaps in each direction when trying to turn left from Meadowlark onto Cottage Grove eastbound. Residents highlighted that they need to turn left from Meadowlark southbound to Cottage Grove eastbound often to go to the Metro Market grocery store.

I did also hear from one dog-walker who is frustrated with the speed of traffic when he crosses Cottage Grove Road at Meadowlark on foot, which is more of a speeding issue, though better pedestrian crossing with a stoplight or other traffic calming might help.

I was forwarded this request for a traffic signal at *Cottage Grove Road (CTH BB) and Meadowlark & Stacy*. I've added this intersection to our list to study this fall as part of our annual traffic signal priority list (TSPL) process. This is our annual process where we perform initial volume counts for each intersection requested to study that year and evaluate it against the traffic signal warrants as outlined in the Manual of Uniform Traffic Control Devices (MUTCD). We present the list of requests to the Transportation Commission in the fall, get approval for intersections to perform further studies on, and present our report and findings a few months later.

I've attached the most up to date list of intersections with requests and where they fall in relationship to the warrants, as well as the final report from last year.

To help us better study this intersection, if either of you had more context to provide that would be greatly appreciated. For example, are residents struggling to find gaps in traffic when crossing by foot or by car? Is there a certain time of day or weekday vs weekend that's an issue? Anything like that.

We also review the crash history, however if residents feel like there are a lot of close calls for a specific type of movement, that could be useful as well.

I cannot find Gorham-Livingston on the TSPL list, at least the one from 2021 that is online. Do we have an updated TSPL list?

Just my cursory review of this intersection indicates that this intersection is nowhere near meeting warrants, as the N approach is a cul-de-sac, N Livingston St is one-way inbound traffic only, and the street grid pattern provides ample access to the neighborhood. There are crossing flags available for pedestrians (at least per the most recent Google Street View image) to carry but no pedestrian warning signs although a standard marked crosswalk exists on all approaches.

As for the WB to SB left-turns from the north travel lane, that is more of an enforcement issue. Who at PD would be a good contact to forward the report?

Thank you for reaching out! Sorry for the late response as I'm out of the office traveling overseas.

Whether to signalize an intersection is a major decision, due to significant cost and impact. It involves hundreds of thousands of dollars of initial investment (the exact cost depends on the location and what underground infrastructure is already in place) and significant ongoing operating and maintenance cost afterwards. It also significantly change the traffic patterns in the area, such as drawing more cut through traffic to the area. There are also national warrants that need to be met. If warranted, traffic signals do improve safety. If not, they actually compromise safety due to incompliance issues. Because of these, we always study these requests and go through a public process.

We haven' have much discussions with the school on the specifics, but we recently studied the High Point-Midtown intersection for a potential traffic signal. The results show that it is 54% below meeting the warrants. We do expect the new school will bring in more traffic and pedestrians, and it will help the intersection get closer to meet the signal warrants. As the intersection is quite far from meeting the warrants. It is prudent to wait till the school opens to reevaluate the situation. We will plan to collect new data and conduct another study when the school is operational. If it does meet the warrants, we will work with the Transportation Commission through the public process.



You are correct that there are specific warrants we have to meet to install traffic signals, as the traffic control has unintended consequences as well. Actually we recently looked at whether to install a traffic signal at the Schroeder-Struck intersection, and it is currently ranked 11<sup>th</sup> on our list for side street stop controlled intersections and is 33% below the warrants. And you are right that we are working with MPD and trying to learn exactly what happened and how we can help to prevent this from happening in the future. We have made quite a bit improvements along the corridor in the last few years, and have 3 additional concrete pedestrian refuge islands programmed this year, to be installed along the corridor at Laurie Dr, Rayovac Dr and the Kwik Trip driveway. These are part of our Safe Streets program and were identified following the last fatality we had on the corridor about a year ago. We hope these improvements will further help the situation on Schroeder Rd.
